



TERMS AND CONDITIONS FOR WINNING A \$1,000 VISA GIFT CARD WHEN YOU SUBMIT AN RFP TO RICHMOND

To Enter: To enter the Contest, event hosts must fill out the RFP form on VisitRichmondBC.com/RFP or call 1-888-297-5673 for assistance. All required fields must be completed in full for consideration. RICHMOND TOURISM ASSOCIATION carrying on business as TOURISM RICHMOND will not be responsible for entries lost, delayed, incomplete or misdirected. Entries will become the sole property of TOURISM RICHMOND.

Eligibility: The Contest is open to residents of North America who are hosting the winning event. Must be 21 years of age or older. By entering, you agree to abide by these rules and all decisions of TOURISM RICHMOND, which are final in all matters relating to this Contest. The Contest commences on January 1, 2019 and will end on December 31, 2019 at 11:59 PM PST.

Qualified entries include RFPs received directly to Tourism Richmond via online RFP form or direct to the Tourism Richmond Sales Department. All RFPs must be confirmed received prior to December 31, 2019 at 11:59 PM PST in order to be entered into the prize draw by Tourism Richmond.

Prize: Two (2) prizes of a \$1,000 Visa Gift Card or donation of \$1,000 to the Winner's Canadian or US registered charity of choice (a "Prize").
