<u>Outstanding Allied Volunteer of the Year</u> - This award recognizes an allied member who best demonstrates outstanding leadership and inspires others to volunteer and contribute toward the enhancement of Associations North.

AWARD NOMINATION PROCESS

- Any Associations North member in good standing may be nominated (or nominate themselves) in as many categories as they may be qualified as a recipient.
- Nominations can be submitted by downloading the form through the Associations North website and returning via email, fax or mail by the prescribed deadline.
- Winners will be announced at the Leadership Conference, recognized in the FOCUS newsletter and Associations North website. Winners will receive a glass award.

AWARD JUDGING PROCESS

- Categories and criteria will be emailed to all Associations North members and posted on the website no less than 45 days prior to the awards presentation.
- Once all nominations are received the Recognition Committee will review them and determine eligibility.
- The Recognition Committee will judge each submission and vote to reach a consensus on a winner in each category. In the event of a tie vote, the Associations North Co-Directors will cast the deciding vote.
- Members of the Recognition Committee will be kept confidential and all members will be instructed not to inform anyone of their involvement or anyone else's. The committee shall be comprised of two allied and two association members, and will not be eligible for this award.
