Participant and/or their parent(s) or guardian hereby waive any and\al! claims including, but not limited to: bodily injury including death and property damage they may have against the City of Rochester and all sponsors of the event and their subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers from arising out of Participant"s participation during the event and all surrounding areas.

Participants and/or their parent(s) or their guardians hereby release and hold harmless the City of Rochester and all sponsors of the event and their subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers from any and all liability for any loss, damage, or expense that the Participants or their respective heirs, assigns and legal representatives may suffer as a result of Participant's participation during the event, from any cause whatsoever, including but not limited to, negligence or breach of contract on the part of the City of Rochester, affiliates, and all sponsors of the event, in the operation, supervision, design, maintenance, or condition of the surface, or of the event and all surrounding areas.
