



# RESTAURANT RELIEF GRANT PROGRAM

## PURPOSE

Illinois State Rep. Maurice West, D-Rockford secured \$1.5 million for a state-funded grant program.

The funding will provide vital relief to restaurants in Rockford and Winnebago County that suffered skyrocketing unemployment insurance rates resulting from state-mandated closures in Q1 2021.

RACVB is the grant administrator, overseeing the application and distribution of funds to eligible restaurants in Winnebago County.





# ELIGIBILITY

**To qualify to apply, an authorized representative of a restaurant will need to certify that.**

1. The restaurant's principal place of business is located within the geographical boundaries of Winnebago County, Illinois.
2. The restaurant complied with the indoor dining closure mandates enacted by the State of Illinois during the first quarter of 2021 via Executive Orders 2021-01, 2021-02, 2021-03, 2021-04, and 2021-05.
3. In complying with indoor dining closure mandates in Q1 of 2021 the restaurant laid off staff and, as a result, has experienced an increase in state unemployment insurance charges.





# ELIGIBILITY, CONTINUED

4. The restaurant incurred and/or will incur a higher rate of state unemployment taxes in 2022, 2023 and 2024, because of the higher unemployment benefit charges in Q1 of 2021.
5. The restaurant remains operational today.

## NAICS CODES

Restaurants must also fall under one of the following two North American Industry Classification System Codes (Business Activity Codes):

- 722511 (Full-Service Restaurants)
- 722513 (Limited-Service Restaurants)

**The restaurant complied with the indoor dining closure mandates enacted by the State of Illinois during the first quarter of 2021 via the following Executive Orders:**

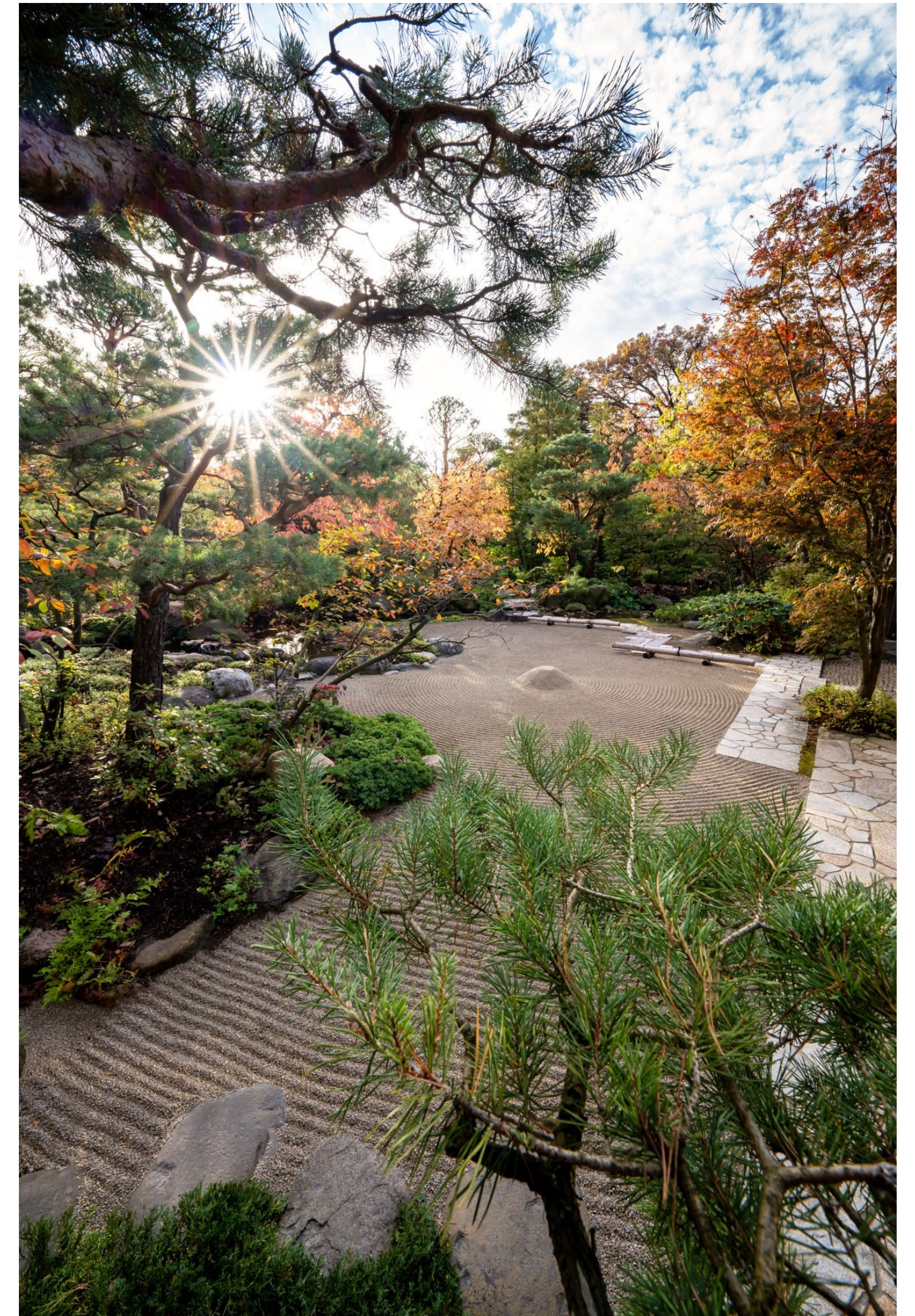
# NOTICE

**Maximum award, per State of Illinois, is \$100k.**

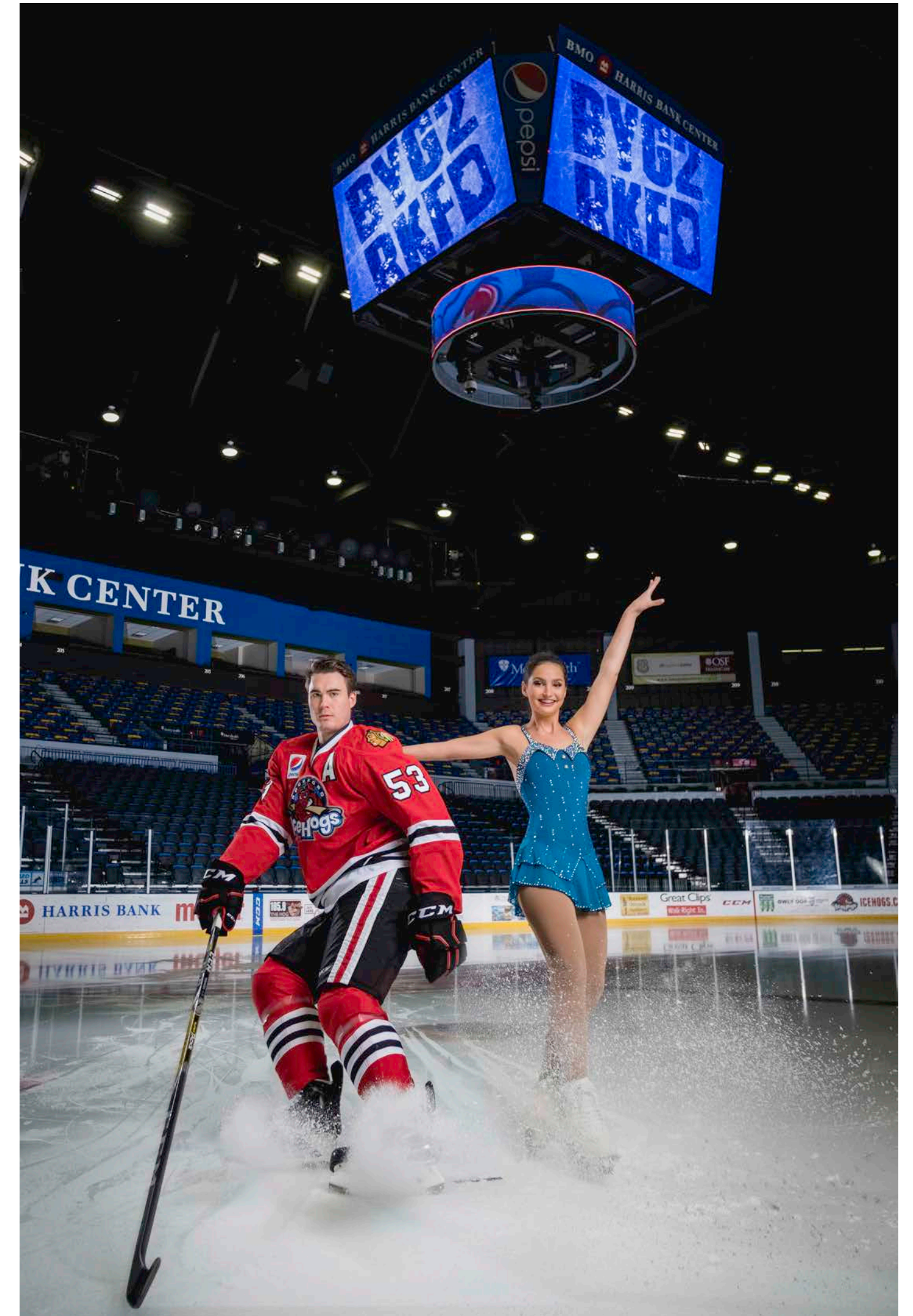




# REQUIRED DOCUMENTS

To qualify, an authorized representative will need to submit the following documents.

- ☐ W-9 for Restaurant
- ☐ 2021 Restaurant Tax Return
- ☐ IL Dept. of Employment Security form BEN-118 – Statement of Benefit Charges for Q1 2021
- ☐ IL Dept. of Employment Security Rate Determination letter for 2021, 2022, 2023 and 2024
- ☐ State Unemployment Tax Reports for 2022 and 2023
- ☐ Proof of payment of State Unemployment Taxes for 2022 and 2023
- ☐ Signed application form

# QUESTIONS & ANSWERS



# QUESTIONS

- **Are chain restaurant owners eligible?** Yes, if all other requirements are met.
- **If a restaurant has more than one location within Winnebago County, can each location apply?** Each unique FEIN can apply separately.
- **Can any restaurant located in the Rockford Region apply?** All restaurants located within Winnebago County are eligible to apply.
- **What if a restaurant closed at some point after Q1-21 but later opened again, are they eligible?** If they temporarily closed and reopened, they would qualify if under the same FEIN.



# QUESTIONS

- **What if an in-dining restaurant closed during Covid and opened as a food truck and is still in operation?** They should explain specifics of their business in the Additional Comments section of the application. RACVB will review these applications on a case-by-case basis.
- **What if a restaurant has more than one NAICS code that applies to its operations, can it apply?** They should explain specifics of their business in the Additional Comments section of the application. RACVB will review these applications on a case-by-case basis.
- **If a restaurant has received revised determination letters for one or more of the years requested, should those be submitted in addition to the original determination letters?** Yes, all IDES determination letters should be submitted, whether original or revised.



# QUESTIONS

- **If a restaurant's payroll provider remits their SUTA taxes to IDES on their behalf, what is acceptable proof of payment?** The restaurant should obtain an affidavit of payment from the payroll provider, indicating the amounts that were paid to IDES on their behalf.
- **When will restaurants be notified of grant awards?** Applications will be reviewed, awards calculated and committee-approved during the month of April, with a goal of having awards announced by the end of April and checks issued the first week of May.
- **How will grant awards be communicated to restaurant owners?** RACVB will announce awards via email to applicants, the GoRockford.com website and a news release to local media.



# QUESTIONS

- **Will grant proceeds be distributed via check or direct deposit?** RACVB will issue a check to the entity listed on the W-9 provided with the grant application.
- **If a restaurant receives a grant, will it be taxable income in 2024?** Restaurant owners should consult with their tax advisors on the taxability of the grant award.



# TIPS/SUGGESTIONS



- Don't send password protected documents, and if you do provide the password.
- Apply in advance of the deadline to allow time for preliminary review and for RACVB to contact you for missing items. All items must be submitted by March 28.
- Clearly name all submitted documents and double check the document to ensure it matches what you think you are submitting.
