Convention Center EIR

The City has published for review the draft environmental impact report (DEIR) for the Convention Center renovation and expansion project as well as the adjacent hotel. The hotel is a private development project planned at 15th and K Street. The public review period is from Nov. 15 to Jan. 2.

Convention Center Stakeholder Meeting

The City held a stakeholder meeting on Tuesday, Nov 14, at the Convention Center. Populous, the project architect, presented the revised concept design that incorporated feedback from the stakeholder group.

Two options were presented, and the group recommended the design that included the second-floor ballroom in addition to the other improvements. The group also recommended a revised schedule that shortens the construction schedule, but results in the closure of the Convention Center between mid-July 2019 and late Fall 2020. Finally, stakeholders were presented with the current cost estimates on the project.

Private Operations

The City received a proposal from a team comprised of the Kings, SMG and Live Nation for private operation of the Convention Center, Community Center Theater, and Memorial Auditorium. City staff is reviewing that proposal and meeting with that team. An update will be provided to Council in December, but a recommendation will not be made until early 2018.

Upcoming Meetings

It is anticipated that staff recommendations on the design and schedule for the Convention Center will be presented to City Council at 5pm on Dec. 12. An update on possible private operations will be provided as well.
