### **Responsibilities**

The 23-member diversified board represents various business sectors, community, and visitor industries as well as a mix of public and private representation. The term of the appointment is up to three years. The board provides policy direction to Visit San Antonio, which includes, but is not limited to budget review and approval, contributing to the formation of marketing strategies, advocating, and generally advising and assisting the President & CEO.

The Board Composition is as follows:

- Two (2) appointments by the Mayor (self or City Council Members)
- One (1) appointment by the City Manager (self or designee/Assistant City Manager)
- Members below would go through a nominating and interview process;
  - Three (3) representing Hotel & Lodging
  - Two (2) representing Leisure Attractions (e.g. Museums/Theme Parks)
  - One (1) representing Restaurant / Culinary Industry
  - One (1) representing Heritage & Preservation
  - One (1) representing Arts/Culture/Music
  - One (1) representing Transportation industry
  - One (1) Chamber representative (All Chambers have the opportunity to apply)
  - Three (3) At Large positions
- One (1) CEO/President of Visit San Antonio
- Ex Officio positions / voting
  - o Executive Director of Economic Development Foundation
  - Director of Convention and Sports Facilities
  - Tourism Public Improvement District (TPID) Board Chair
- Ex Officio positions / non-voting
  - Director of Aviation
  - o Director/Assistant Director of Military Affairs
  - o San Antonio Hotel & Lodging Association (SAHLA) President & CEO

- February 14 Nomination process opens. Applicants may self-nominate.
- March 20 Official applications due. Materials must be electronically submitted or postmarked by 5 p.m. CST.
- April 12 & 18 Board interviews will be conducted by the Nominating Committee.
  - Interviews will be conducted at the discretion of the nominating committee.
- May 1 New Visit San Antonio Board Members will be announced.
