

Visit San Antonio Summer Getaway Sweepstakes

Official Rules

The following Sweepstakes is intended for participants in the United States only and shall be construed and evaluated according to the laws of the United States. Do not proceed in this Sweepstakes if you are not a legal resident of the United States.

The Sponsor of the Sweepstakes is Visit San Antonio, 110 Losoya St, San Antonio, TX 78205 (“**Sponsor**”). The personal data included in entries will be collected by Sponsor in accordance with the privacy policy set forth at www.VisitSanAntonio.com/legal.

1. Eligibility: No purchase necessary. Open to legal residents of the 50 United States and the District of Columbia, (“**U.S.**”) who are at least 18 years of age or older or have reached the age of majority in their state of residence at the time of entry. The Visit San Antonio Celebration Sweepstakes (the "**Sweepstakes**") is governed by US law and is subject to all applicable federal, and state laws and regulations. Employees, officers and directors of Sponsor, its affiliates, participating prize suppliers, and each of their respective parents, affiliates, agents, contractors, subsidiaries, advertising, promotion and fulfillment agencies (collectively, the “**Promotion Entities**”) and members of the immediate family or household of each are not eligible to participate. Potential winner will be notified by email and/or by phone (as Administrator elects) using the contact information provided at the time of entry. Sponsor shall have no liability for any notification that is lost, intercepted or not received for any reason. If, despite reasonable efforts, any potential winner does not respond within (48) hours of the first notification attempt (the placing of the call or the sending of the email), or if prize notification is returned as unclaimed or undeliverable, such potential winner will forfeit prize and at Sponsor’s discretion, an alternate potential winner may be

selected.
