1. Promotion Overview

The Flavors of the Peninsula — Grand Prize World Cup Experience Sweepstakes (the "Sweepstakes") is a promotional sweepstakes sponsored by the San Mateo County/Silicon Valley Convention & Visitors Bureau, doing business as The San Francisco Peninsula ("Sponsor"), located at 111 Anza Blvd., Suite 410, Burlingame, CA 94010. The Sweepstakes is conducted in connection with the Flavors of the Peninsula dining program and the Bandwango digital pass platform. This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with FIFA, the FIFA World Cup 2026™, or any related official entities. By entering this Sweepstakes, each entrant accepts and agrees to these Official Rules and the decisions of Sponsor, which shall be final in all matters.

2. Promotion Period

The Sweepstakes begins on April 23, 2026 at 12:00:01 AM Pacific Time ("PT") and ends on May 3, 2026 at 11:59:59 PM PT (the "Promotion Period"). Entries received outside the Promotion Period will not be eligible. Sponsor's computer is the official timekeeping device for this Sweepstakes.

3. Eligibility

To be eligible to enter and win, participants must meet ALL of the following criteria at the time of entry:

- Be at least eighteen (18) years of age or the age of majority in their jurisdiction of residence, whichever is greater, at the time of entry;
- Be a legal resident of California;
- Have a valid email address and a mobile device capable of accessing the Bandwango digital pass platform; and
- Comply with all terms and conditions set forth in these Official Rules.

INELIGIBLE PERSONS: Employees, officers, directors, agents, and representatives of Sponsor, Bandwango, af&co., participating Flavors of the Peninsula restaurants, prize providers (including The Ameswell Hotel and American Express), and their respective parent companies, subsidiaries, affiliates, and advertising and promotion agencies, and the immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they live) or household members of any such person are NOT eligible to participate or win.

4. How to Enter

METHOD OF ENTRY — NO PURCHASE NECESSARY:

Primary Method (Bandwango Digital Pass):

1. During the Promotion Period, visit <https://www.thesanfranciscopeninsula.com/food-and-drink/flavors-of-the-peninsula/> and download or access the Flavors of the Peninsula Bandwango Pass (the "Pass").
2. Using the Pass, check in at a minimum of two (2) Participating Restaurants during the Promotion Period. Each check-in must be completed in-person at the physical restaurant location. No purchase is necessary.
3. Upon completing at least two (2) qualifying check-ins, the participant will automatically receive one (1) entry into the Sweepstakes drawing.
4. Limit: one (1) entry per person, regardless of the number of check-ins completed. Multiple check-ins beyond the two (2) minimum do not generate additional entries.

Alternate Method of Entry (AMOE) — No Purchase or App Download Required:

To enter without downloading the Bandwango Pass or visiting a restaurant, mail a 3" x 5" card with your full legal name, mailing address, email address, date of birth, and daytime telephone number to: Flavors of the Peninsula Sweepstakes, c/o The San Francisco Peninsula, 111 Anza Blvd., Suite 410, Burlingame, CA 94010. Mail-in entries must be postmarked by May 4, 2026 and received by May 8, 2026. Limit one (1) mail-in entry per outer envelope. AMOE entrants receive the same number of entries as primary method entrants. Mechanically reproduced entries are void. No more than one entry per day per person is permitted.

5. Participating Restaurants

The list of Participating Restaurants is subject to change during the Promotion Period at Sponsor's sole discretion. Sponsor is not responsible for restaurants that withdraw from the program after the Promotion Period begins. Check-ins at non-participating restaurants do not qualify for entry.

6. Prize Description and Approximate Retail Value

One (1) Grand Prize will be awarded, consisting of:

- Two (2) tickets to the FIFA World Cup 2026™ match on June 25, 2026, at 7:00 PM (match: Paraguay v. Australia), to be held at Levi's Stadium, Santa Clara, California.
ARV: \$400 each
- One (1) one-night hotel stay for two (2) at The Ameswell Hotel, Mountain View, California, subject to availability. Blackout dates and room type restrictions may apply. Must be redeemed by July 1, 2026.
ARV: approximately \$450
- One (1) \$200.00 American Express Gift Card.
ARV: \$200.00

Total Grand Prize ARV: approximately \$1700. Prize is non-transferable, non-assignable, and has no cash equivalent. No substitution of the Prize (or any component thereof) by winner is permitted. Sponsor reserves the right to substitute a prize of equal or greater value if any component of the advertised prize becomes unavailable for any reason. Winner is solely responsible for all applicable federal, state, and local taxes and all costs and expenses not explicitly described herein, including but not limited to transportation to and from the venue.

7. Winner Selection and Notification

Selection: On May 11, 2026, a potential winner will be selected in a random drawing from among all eligible entries received during the Promotion Period. The drawing will be conducted by Sponsor or its designated representative. Odds of winning depend on the total number of eligible entries received.

Notification: The potential winner will be notified by email (and/or phone, at Sponsor's discretion) within seven (7) business days of the drawing. If the potential winner cannot be contacted within seven (7) business days of the first notification attempt, or if the potential winner fails to respond within seven (7) business days of notification, the prize may be forfeited, and an alternate winner may be selected from the remaining eligible entries.

Verification: The potential winner may be required to complete and return an Affidavit of Eligibility, Liability Release, and (where permitted by law) Publicity Release within 14 business days of notification. Failure to return required documents within the specified time, or if any prize notification or required documents are returned as undeliverable, may result in disqualification and selection of an alternate winner. Only three (3) alternate drawings will be held, after which the prize will remain unawarded.

8. Prize Conditions and Restrictions

- The World Cup match tickets are for the specific game identified in Section 6. If the game is rescheduled, relocated, or canceled for any reason, Sponsor is not responsible for providing substitute tickets or compensation. Sponsor makes no representation regarding ticket availability for any other match.
- The hotel stay is subject to availability at the time of redemption and must be used by July 1, 2026. Winner is responsible for all incidentals, taxes, room upgrades, and expenses not expressly included in the prize.
- Winner is responsible for all costs associated with transportation to and from all prize components, including but not limited to the venue and hotel.

- The \$200 American Express Gift Card is subject to American Express's terms and conditions.
- All prize components must be accepted as awarded. Unused prize components have no cash value.
- Winner may be required to present valid government-issued photo identification to claim tickets or hotel accommodations.
- The prize is awarded to the winner only; prize components cannot be transferred or sold. If winner is unable to attend the game, the prize may be forfeited at Sponsor's discretion.

9. General Conditions

- Sponsor reserves the right, in its sole discretion, to cancel, suspend, or modify the Sweepstakes, or any part of it, if fraud, technical failures, human error, or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor.
- Sponsor reserves the right to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes, acting in violation of these Official Rules, or acting in a disruptive or unsportsmanlike manner.
- Any attempt by a person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek remedies against any such person to the fullest extent permitted by law.
- Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- In the event of a dispute regarding the identity of an entrant, the entry will be deemed submitted by the authorized account holder of the email address associated with the Bandwango Pass account or the mailing address on the AMOE entry.
- Sweepstakes void where prohibited, taxed, or restricted by law.
- By participating in this Sweepstakes, each entrant agrees to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all matters relating to the Sweepstakes.
- Sponsor and its agents are not responsible for: lost, late, incomplete, invalid, unintelligible, or misdirected entries; technical failures of any kind; unauthorized human intervention; printing or typographical errors; or any combination thereof.

10. Limitation of Liability

By entering the Sweepstakes, entrants hereby release and hold harmless Sponsor, Bandwango, participating restaurants, prize providers, and each of their respective parent companies, subsidiaries, affiliates, officers, directors, employees, and agents from any and all claims, losses, harm, damages, costs, or expenses (including reasonable attorneys' fees) arising out of or in connection with: (a) the Sweepstakes; (b) the acceptance, possession, use, or misuse of any prize; or (c) any violation of these Official Rules. Sponsor is not responsible for any typographical or other error in the printing of the offer, administration of the Sweepstakes, or announcement of prizes. Sponsor will not be responsible for late, incomplete, or incorrect

entries; an entrant's failure to receive prize notices due to entrant's spam, junk e-mail, or other security settings or for entrants' provision of incorrect or otherwise non-functioning contact information; technical, hardware, or software malfunctions, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, garbled, or delayed electronic communications whether caused by the sender or by any of the equipment or programming associated with or used in this Sweepstakes; by any human error which may occur in the processing of the entries in this Sweepstakes; or any typographical, technological, or other error in the publishing of the offer, administration of the Sweepstakes, or announcement of the Prizes.

11. Privacy and Data Use

Personal information collected in connection with this Sweepstakes (including name, email address, and check-in data collected through Bandwango) will be used for purposes of administering the Sweepstakes, including contacting and verifying the winner. Information may also be used by Sponsor to communicate about The San Francisco Peninsula programs and events, subject to the Sponsor's Privacy Policy available at <https://www.thesanfranciscopeninsula.com/privacy-policy/>. Bandwango's collection and use of personal data is governed by Bandwango's own privacy policy. Entrants agree that Sponsor and Bandwango may share data as necessary to administer the Sweepstakes.

12. Publicity

Except where prohibited by law, by accepting a prize, the winner grants Sponsor permission to use their name, city and state of residence, photograph, likeness, voice, and/or biographical information for advertising and promotional purposes in any media now known or hereafter developed, worldwide and in perpetuity, without additional compensation or prior notice.

13. Disputes and Governing Law

Except where prohibited, as a condition of participating in this Sweepstakes, entrant agrees that: (a) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration by, and under the rules of, the American Arbitration Association and held in San Mateo County, California; (b) the Federal Arbitration Act, federal arbitration law, and the laws of the State of California, without reference to its choice of law rules, govern the Sweepstakes and these Official Rules; and (c) under no circumstances will either an entrant or Sponsor be permitted to obtain an award against the other for, and each hereby waives all rights to claim, punitive, incidental, or consequential damages.

14. Third-Party Platform Disclaimer

This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Bandwango, FIFA, the FIFA World Cup 2026™, Levi's Stadium, or any other third-party platform, brand, or entity referenced herein.
