Rick Guidotti worked as a photographer in NYC, Milan and Paris for high profile clients. He took photographs of those that others considered the world's most beautiful people. One day he saw a girl at a bus stop. She had pale skin and white hair; a girl with albinism. Rick began a process of discovery about people with differences and about himself. What he found was upsetting. The images he saw were sad and dehumanizing.



He stopped working in the fashion industry and created a not-for-profit called **Positive Exposure**. What started with photographs, has grown into a variety of programs to empower people living with differences, and to educate the world around them.
