

**Sound Transit Link Light Rail  
Flexible Date Day Pass Agreement**

This Agreement is entered into by and between the Central Puget Sound Regional Transit Authority (“Sound Transit”) and \_\_\_\_\_ (“Buyer”). Buyer is purchasing flexible date day pass tickets from Sound Transit for use by its guests on Sound Transit’s Link Light Rail system (“Day Passes”). This Agreement governs the terms of use by which Buyer may purchase and distribute Day Passes.

1. **Ticket Must be Dated for the Day of Use. Buyer must write or print *in ink* the date of use on the front of each Day Pass, prior to distributing to guests. Undated Day Passes are not valid. Undated Day Passes may not be distributed to guests.**
2. **Single Day Use Only.** Each Day Pass enables the holder to ride Link Light Rail for an unlimited number of trips on the date written or printed on the front of the Day Pass. The Day Pass expires at 11:59pm on the date written on the front of the ticket.
3. **Valid Only on Link Light Rail.** Day Passes are good only on Link Light Rail and cannot be used on buses, Amtrak, commuter rail, street car, monorail, or ferries.
4. **Holder Must Present Ticket When Asked.** The holder must present the Day Pass as proof of payment when requested to do so by Sound Transit fare enforcement. Day Passes are valid only on the date indicated on the front of the ticket. Day Passes that are undated, written in pencil, or modified (eraser marks, cross-outs) will not be accepted as valid proof of payment and may subject the holder to a \$124 fine pursuant to RCW 81.112.220.
5. **Distribution to Hotel Guests Only; No Resale or Duplication.** Day Passes are for courtesy distribution to Buyer’s guests only. Buyer may not sell Day Passes. Day Passes may not be duplicated and can be purchased only from Sound Transit.
6. **No Refunds or Exchanges.** Day Passes must be used in the year printed on the front of the ticket. No refunds or exchanges will be given for unused tickets that have expired. Sound Transit is unable to replace lost or stolen Day Passes.
7. **Future Sales at Sound Transit’s Discretion.** Failure to comply with the terms of this Agreement, including failure to write in date of use prior to distribution to guests, may result in Buyer’s ineligibility to purchase additional Day Passes from Sound Transit. Sound Transit may discontinue or modify the Day Pass program at any time, but will honor previously sold and properly dated Day Passes.

Buyer has read and agrees to comply with these terms of use.
