IT'S FINALLY HAPPENING, LEGISLATURE HAS STARTED PRINTING BUDGET BILLS

<u>City & State:</u> At long last, the state Legislature has started printing budget bills, paving the way for legislators to begin hours of marathon voting to finally get the spending plan wrapped up. As of early Wednesday morning, the Legislature had introduced three of the

remaining nine budget bills, leaving six more that still need printing. ALBANY SNEAKS IN BUDGET LANGUAGE THAT WOULD PUT NY TAXPAYERS ON THE HOOK FOR TISH JAMES LEGAL BILLS

NY Post: Albany Democrats are expected to sign off on a provision allowing certain officials to tap into a \$10 million fund to cover "any reasonable attorneys' fees and expenses incurred" — even as part of probes not directly related to their state employment. The language is being slipped into New York's operations budget bill — one of several expected to be made public and voted on starting Wednesday as the Legislature moves to pass next year's fiscal plan.

NYS BUDGET DELAY CREATES UNCERTAINTY AHEAD OF SCHOOL BUDGET VOTES

Spectrum News: School districts across New York are preparing for critical budget votes on May 20. But without hard data on state funding, districts that are facing rising costs and deficits will have to make difficult decisions. "Boards had to make decisions, and it's not ideal to not know for certain what will happen," said Robert Lowry, deputy director of the state Council of School Superintendents. Lowry added that for the poorest school systems, the margin for error is razor-thin. "About 25% of the districts in the state that are so small and so poor, that a 1% increase in their property tax won't raise \$100,000," explained Lowry. "And so that would not be enough to save more than one teaching position."

HOCHUL TO DRAIN STATE RESERVES TO PAY OFF S7B IN UNEMPLOYMENT INSURANCE DEBT

NY Post: Gov. Kathy Hochul is delivering a big win to businesses that have been pressuring her to pay off their billions of dollars in unemployment-insurance debt — but she's stealing the cash from state reserves to do it. Hochul said Monday that the state will cover the roughly \$7 billion debt still lingering for employers from the pandemic. The businesses had hoped federal money that the state received during COVID-19 would at least partly be used to help cover the deluge of unemployment claims spurred by the pandemic, as most other states did.

RITE AID CLOSURE LIST: 178 STORES SHUTTING DOWN AFTER BANKRUPTCY

<u>FL1:</u> Rite Aid has officially filed for bankruptcy protection again, and this time, it's having a major impact on New York State. The struggling pharmacy chain announced it will permanently close all 178 Rite Aid locations across New York by next month, following its second Chapter 11 bankruptcy filing in less than two years..
