NY LAWMAKERS PROPOSE TASKFORCE TO EXAMINE CRYPTO INDUSTRY

Spectrum: Head of state's banking committee is calling for a 16 person task force to look into the entire crypto industry. This task force would appointed by the Governor and legislators.

Olean Times Herald: Hochul is urged to revisit the HEAT Act, which caps energy bills at 6% of middle/low income families income & enforces 100 Foot Rule (families within 100 feet of a gas line must get a new gas line installed free of cost from utility company)

AFTER FALLING AT HISTORIC RATES. NYC LOOKING TO INCREASE LIFE EXPECTANCY BY 2030

NBC 4 NY: Before COVID NYC life expectance was 82.6 years; after it was 78 years; today it's around 80. Mayor Adams plans to address issues relating to early death in NYC.

NY SUPREME COURT REINSTATES SACKED UNVACCINATED EMPLOYEES

headtopics: Public workers fired for being unvaccinated are reinstated; Supreme Court finds that vaccines don't stop the spread or contraction of COVID-19.

WHY NY AND NJ ARE SEEING A BURST OF SOUNDSTAGE AND PRODUCTION FACILITY CONSTRUCTION

Variety: NYC is seeing a boom in the production industry; the state has brought back the 30% tax credit for that industry through the year 2034.

AS GAMES CONTINUE. SPORT BETTING GROWS IN NY

Spectrum: Research shows that between Sept. 5, 2022 and the Superbowl (Feb. 2023) over \$8 million was brought in through sports betting. NYS received \$380 mil in tax revenue.

LAWMAKERS WEIGH MOBILE CASINO GAMING TO BOOST STATE REVENUE

Spectrum: Legislation is looking to create mobile gaming for casinos (like Blackjack, etc.) and if passed, expects to net \$1 billion in the first year.

WHAT THE LATEST NY 2024 BUDGET NUMBERS TELL US ABOUT POTENTIAL DEFICIT

Lohud: Gov. Hochul is expected to release the budget in two months; the deficit looks like it was cut by about \$4 billion and is now at \$4.3 billion.

POLS CALL TO CUT MILLIONS IN STATE FUNDING TO COLUMBIA, CORNELL OVER ANTISEMITISM

NY Post: Politicals want funding cut for schools that have had antisemitism from students; Cornell currently fund four different colleges and receives \$200 million/year. Without the funding those schools will be greatly impacted.

- Brainstorming is currently happening over the milk shortage that's occurring
- While Seneca Falls plans to use cheese sticks to supplement the shortage; South Seneca School District is looking into other options
- Options discussed:
- -Serving milk in cups
- -Investing in milk dispenser equipment (this may not be readily available in time to fix the issue)
 - Schools receive state aid attached to the NYS Lottery;
 - With sports betting happening, schools are now set to receive aid from that
 - State aid formulas when it comes to lottery are complicated and not easily understood; districts will be paying attention to the trends over the next few years to better understand the aid
