CHAMBER PRESIDENT & CEO JEFF SHIPLEY

- Tuesday's Board meeting focused on a bridge and culvert in the county in need of repairs:
- -Bridge on County House Rd. over Silver Creek needs funding for design and construction- propositioned \$1.2 million from NYS
- -Culvert on Wires Point over Groves Creek needs funding for design and construction- propositioned \$2.7 million from NYS

COUNTY DIRECTOR OF PLANNING AND COMMUNITY DEVELOPMENT, JILL HENRY

- Airport Advisory meeting discussed upcoming grant project that would increase hangar space
- \$2.3 million was received in a grant for that project from DOT and construction and movement on that should start in the spring

NYS COURT OF APPEALS RULES CONGRESSIONAL LINES MUST BE REDRAWN

<u>Spectrum:</u> Law in NYS requires non-biased congressional lines drawn, and after back and forth arguments over gerrymandering, a judge has ordered it to be redrawn again.

THESE HOUSE REPUBLICANS COULD BE THE TARGETS OF NEW YORK REDISTRICTING

New York Times: Brandon Williams of Syracuse may be targeted so the lines redrawn will change to include Ithaca, a Democratic majority, which would be the same tactic as before and was sued for gerrymandering.

IN RACE TO REPLACE GEORGE SANTOS, NY'S NEW VOTE BY MAIL FACES AN EARLY TEST

Gothamist: Special election in February to replace George Santos will happen after the vote by mail law goes into effect Jan. 1. The law in currently being challenged; it allows anyone for any reason to vote by mail, where before there needed to be a reason provided

NEW YORK'S RURAL SCHOOL DISTRICTS SAY THEY'RE AT A CRITICAL MOMENT

<u>Spectrum:</u> NYS Board of Regents looks to update the process of Foundation Aid Formula. Executive Director of Rural School Association of New York went on a media tour to address critical needs in rural districts, including access to mental health help.

DOZENS OF ELECTED OFFICIALS OPPOSE EXPANSION OF TWO NATURAL GAS STATIONS

<u>Times Union:</u> Renewed interest in hydrofracking has dozens of elected officials opposing the expansion of two gas stations; it would impact Athens, a disadvantaged community.

Empire Report: NYS roads and bridges are declining after the state received a multi billion dollar grant for funding to fix it. Inflation knocked a full year off of the five year plan and the DOT is now calling for funding to keep the project going.

IDA DIRECTOR, SARAH DAVIS

- IDA Office has been looking at Micron development in the county and is reaching out to other towns that have experienced development within 50 miles of their town to see what Seneca County should expect
- Meeting last week for Willard included the County Manager signing off on MRB agreement to look for expressions of interest
- Memorandum of Understanding is in the works for a title transfer from the state to the county

STEVE ZIELINSKI PARKER, SOUTH SENEGA SCHOOL DISTRICT SUPERINTENDENT

- The redoing of the Foundation Aid Formula is a reset for the process; what to expect with that and how long it could last is currently unknown
- Seneca Falls passed their referendum for their Capital Project; the Capital Aid was worth \$24 million with an aid ration of .88 on the \$1
- The money is taxpayer money so taxpayers express wanting to know where it's going; No matter what at the end of it all Albany has that money and the money coming back to go into the local economy and benefit its residents and taxpayers
