- Discussions with administrators across the state show a want for getting into the Al space
- Syracuse University Maxwell School has started an Al Gov. section of the school itself and hired tech people to come in and teach Al courses
- School will be putting out some Al government courses for local administrators, directors, and department heads
- Optimistic about Willard project

- Public hearing set for Groggery development project
- Housing development for former Groggery restaurant in the hamlet of Fayette, looking to turn it into six housing units and a commercial retail space
- Hearing is scheduled for March 14th at 6 p.m. at the Favette Town Hall
- After public hearing, the Fayette Town Board will hold their meeting that night

- Busy; a lot of economic activity out there
- Accepting 3.2 new clients per day which is leading the state
- Seneca County numbers are higher than they've been in a long time; 25 active projects in the county

- Advocacy season is more intense than usual with foundation aid issue
- Most messaging is that it might work out in the end; universal agreement that safe harmless should not be quickly and abruptly ended
- This year will be okay but it will still be hard when it does end

CAROL DOOLITTLE, FRONTENAC

- EPR- wineries and businesses would be responsible for the disposal of products, but also to use less
- Farm bureau is still against EPR because they want food exempted
- None of the other 7 states have exempted food or farm products
- This has been discussed since 2020
- The plastic industry is against this
- Wine industry decided \$5 million for us in the county is good and to not let is pass by
- Bottle bill: will effect everyone
- · Wineries can refill their bottles
- Milk industry against this even though they can was and reuse their glass milk bottles like Byrne Dairy does
