

#### DOZENS OF NY LAWMAKERS OPEN TO REJECT BUDGET OVER HOUSING

<u>Spectrum:</u> Rent is controlled in NYC; a 3 % cap increase is currently in place for landlords and tenants. While many want to keep the 3% max increase in place to protect tenants, the other side wants it to increase so landlords can recoup the costs that go into renovations and investments for properties.

#### NY LAWMAKERS WANT TO DEFINE SQUATTERS AS TRESPASSERS. NOT TENANTS

<u>CBS New York:</u> The law currently states that once a squatter has spent thirty days in a dwelling, they then gain tenant rights. Lawmakers want that to change and have those squatting be recognized as trespassers.

#### NYS BUDGET TALKS MAY DRAG INTO THIRD WEEK, HOUSING IS MAIN STICKING POINT

<u>Daily News:</u> Medicaid is another point in the budget; Hochul wants to cut \$1 million from the Medicaid budge, lawmakers want to expand a special federal waiver that puts NYS funding toward Medicaid. It also appears Hochul has stopped her push to cut foundation aid

#### EPA FINALIZES LONG-AWAITED NATIONAL PFAF'S DRINKING WATER STANDARD

Harris Beach: EPA standards are stronger than NYS standards for water in some cases; municipalities are responsible for public water systems and may end up on the hook for EPA standards to be met. Money has been made available to get these systems in compliance with the higher standards. By reclassifying these levels, it can impact farms, landfills, airports, and other industries who may need to protect themselves.

#### **EDITORIAL: THE CANNABIS CONUNDRUM**

<u>Times Union</u>: Licensed cannabis retailers account for \$100 million in sales this last year, but illegally run businesses without a license account for \$7 billion. Laws placed on licensed retailers have stricter standards; those not following the laws don't abide by those rules. Could this result in re-criminalizing cannabis sales?

#### Water and Sewer Commissioner NY RANKS LAST IN ECONOMIC OUTLOOK STUDY OF ALL 50 STATES

<u>Fox Business:</u> Numerous reasons: highest for top personal and income tax rates, highly regulatory, highest workers compensation, etc.
