NYUP: New York state's bid to land a new national computer chip research center is facing considerable competition from other states, including Oregon.

GOOD CAUSE EVICTION'S LEGAL LITMUS TEST BEGINS

<u>City Limits:</u> In principle, good cause is a housing court defense that protects tenants from eviction without a legally sufficient reason, such as failing to pay rent, violating lease terms, or being a nuisance. It can also provide defense against rent increases over a certain threshold.

<u>City & State:</u> Albany, Kingston and Poughkeepsie have all passed localized versions of New York's "good-cause" law.

<u>FL Daily News:</u> Legislation would allow EMS agencies and ambulance networks to be reimbursed for treating patients at the scene of the incident and/or transporting them to non-emergency room-based care facilities for treatment and triage.

<u>FL Times:</u> Trains for what is being called the nation's first true high-speed rail line between Las Vegas and the Los Angeles area will be built at a new factory in upstate New York.

<u>FL Times:</u> From now until 2033, Seneca County should continue to dispose of most of its solid waste at a landfill but should also take several steps to divert how much ends up in those landfills.
