## NEW YORK'S FIGHT OVER WHETHER TO AID ICE HEATS UP IN ALBANY

Gothamist: A group of state lawmakers are creating the New York for All Act- it stops the requirement of the state and local government to use public resources for helping ICE. This has been playing out locally in places like Ithaca/Tompkins County.

### 78% SUPPORT WINE IN GROCERY STORES AS LIQUOR SHOPS PUSH BACK

<u>WGRZ Buffalo:</u> A Siena College poll found that 78% of New Yorkers support letting grocery stores sell wine. Voters supported the proposal, even as the state maintains a Prohibition-era rule keeping wine out of those stores. Liquor stores are pushing back saying it can harm small businesses like their own.

### NEW YORK LAWMAKERS PROPOSE LITIGATION TO MITIGATE PFAS EXPOSURE

NYStateofPolitics: The group of bills includes banning the use of PFAS in consumer and household products, cosmetic products and menstrual products. Additionally, the bills would regulate PFAS as an air pollutant and require the disclosure of PFAS levels in all permitted facilities discharging waste.

### OVID COMMUNITY CONTINUES TO RALLY AFTER DOWNTOWN FIRE

FL1: More than \$20,000 was raised on February 1 during a fundraiser at the Ovid VFW, benefiting the Ovid Fire Fundraiser. This critical event drew strong community support following the destructive fire on January 21 that displaced employees and caused significant loss to the town's identity. An exact total of funds raised will be confirmed by the VFW in the coming days. The fire, which devastated the Ovid Big M and other parts of the town's business district, left many grappling with the shock of losing their jobs and a central part of the community. In response, efforts have multiplied to provide aid to those in need, with local businesses and organizations stepping up. Big M employees, for example, organized a pop-up community grocery store to deliver essential items to homebound residents. Rebuilding their customer records from memory after their documentation was destroyed in the fire, they coordinated with United Way of Seneca County to continue supporting those without immediate access to food and supplies. The Edith B. Ford Memorial Library in Ovid has also become a hub for community recovery. Despite facing ash and soot contamination, the library resumed operations quickly, offering meeting space to human services organizations and the New York State Department of Labor's Rapid Response Team. Lodi Whittier Library organized a creative writing workshop focused on resilience and healing, beginning February 10. Local businesses have joined the relief effort as well. Pat's Pizzeria donated pizzas to fire departments across Seneca County during a recent station clean-up event. Additionally, ServU Credit Union contributed \$2,000 to Catholic Charities of the Finger Lakes and donated a vehicle to a displaced family. This spirit of solidarity was echoed at a community meeting held Saturday at the Ovid Federated Church. Participants expressed gratitude for the ongoing efforts and shared plans for long-term recovery initiatives.

#### NEW SHORT TERM RENTAL LAW

<u>NYSHTA:</u> The new law requires that platforms like Airbnb and VRBO report information four times a year to New York State, including a full list of rental locations and taxes collected, by county. Counties can then opt to receive that information, and use it create accurate STR registries.
