THRIFT SHOP TO HELP OVID WILL BE OPEN FIVE DAYS

Finger Lakes Times: The United Way of Seneca County had planned to open a one-day thrift shop on Wednesday to help those affected by the devastating fire in downtown Ovid last month.

On Monday afternoon, the agency announced that the store will be open five consecutive days. The #OvidStrong Thrift Shop 2.0 will set up in an empty store space (suite 79) at Finger Lakes Premium Outlets in Junius, between Skechers and Kate Spade, and be open from 10 a.m. to 6 p.m. all five days. Clothes, shoes, toys, and smaller household items will be included in the \$5 bag sale. Coats will be sold for \$3 or two for \$5, the same as blankets, sheets, and pillows. Bags, purses, and backpacks cost \$1 apiece. Furniture and larger household items are priced individually. Cash and credit will be accepted.
