- D. **Tourism Summary Report** Ms. Brown reviewed August and September tourism summary reports.
- E. **Mardi Gras Update** The Finance Committee made a motion to assist with the cost of additional officers, up to 2/3 of the total from the ARPA funds; seconded by Mr. Roberts. All in favor none opposed with no public comment.
- F. **Grant Applications Rock the Clock** After further review, the Finance Committee has determined this event does not fit the grant criteria. However, VSB will assist in marketing.

### **President Reports**

Mr. Johnson updated the board on the noise ordinance that the City of Shreveport City Council is discussing, how it impacts tourism, and shifting the discussion to space and the entertainment district.

Mr. Johnson met with the Dream Keeper Alliance regarding a festival on the weekend of Martin Luther King's holiday called "Dream Festival". This would be a regional event.

Mr. Anderson discussed with the board regarding the blight and gateways to the cities, proposing a committee of agencies and the community to discuss.

- Boom or Bust Interpretive Pavilion is now out for bid by DOTD. Will be located at Earl G. Williamson Park.
