President Reports

Ms. Brown provided updates on the Boom or Bust Byway Corridor Management Plan; Equine Arena proposal and DMP Steering Committee.

Strategic Planning Update: Staff agreed with the board's recommendation to narrow down to a purpose statement and proposed the following: "Two Cities. One Heart. Uniting the Communities Through Tourism, Sports, Festivals, and Events."

Communications: Public relations value YTD is \$4.7 million; mentions 7,542 vetted clips and more than 4 billion in circulated reach. Currently working on a new banner for the VSB home page. Traveling to Dallas for the Culinary Trails with two chefs from the Shreveport-Bossier area. I-20 Traffic Talk will be sharing alternate routes to get to businesses in the area during the I-20 construction.

Conventions: Attended Connect Marketplace in Minnesota; the team conducted 70+ one-on-one meetings with vetted meetings and event planners. Hosted the National Square Dance Executive Committee for the March 2024 pre-conference and June 2025 National Convention. The Louisiana Relator Association will be here in September 2023, with 306 booked rooms. The National Tour Association is scheduled to be here on November 2023 with 2,134 booked rooms.

Sports Commission: Hosted the Gulf Coast Athletic Conference on a site visit for the GCAC Volleyball Championships to be held November 4-7, 2023. Attended the Louisiana Travel Summit, met with statewide partners, and discussed certain standards to put in place for sports. The sports team had their staff retreat to discuss policies and practices that they would like to implement and discussed the 2024 budget.
