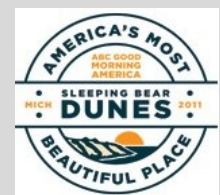

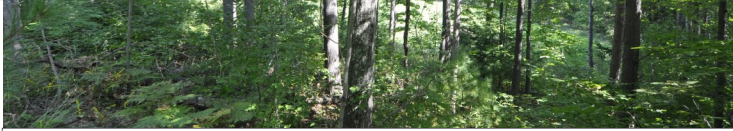

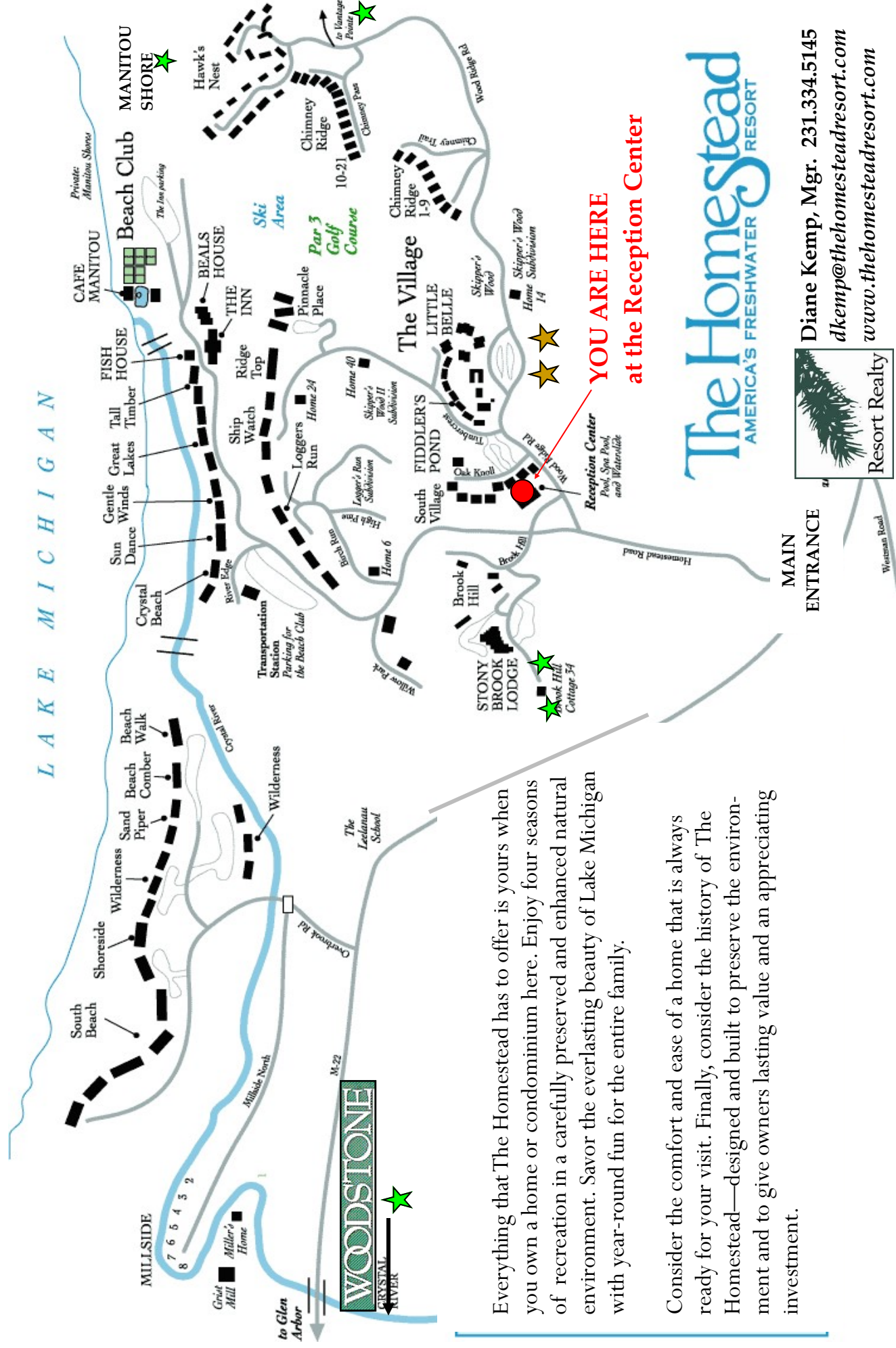

## What is Fractional Ownership?

- **6 weeks** (*Eighth Ownership*) at Fish House, Beals House, Shoreside, Shoreside North, 33 Timber Crest or The Inn.
- **12 weeks** (*Quarter Ownership*) at Brook Hill or Pinnacle Place.
- **4 weeks** (*Twelfth Ownership*) at Camp Firefly

The weeks you own are spaced evenly throughout the four seasons of the year on a preset schedule. The schedule rotates between the owners of the time periods, so that over a four, eight or twelve year period each owner will have had every week of the year. The Owner’s Schedule for many years allows the owner to make vacation plans in advance. Owners of the time periods are indicated by the letters A through H for eighth ownership, A B C D for quarter ownership and A through L for twelfth ownership.
