



## SLO CAL Getaway Giveaway Rules

Void where prohibited. The contest begins on **October 16, 2023 at 12:01 AM PST** and ends on **October 26, 2023 11:59 PM PST**. All times in this contest refer to Pacific Time. By entering the contest, entrants agree to waive any right to claim any ambiguity or error in these Official Rules, or the drawing itself, and agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are binding and final.
