Steve Page – Sonoma Raceway – Update

Moved Steve up in agenda because he has another meeting at 8:30.

Sonoma Raceway has taken over the SimRaceway racing school, as of Jan 1, 2020. Now called Sears Point Racing Experience, a fully-owned subsidiary of Sonoma Raceway. Business model shift from large events (currently there are two big events – NASCAR and NHRA) to rentals and smaller events. The business of large spectator events is much harder and there is more demand for various events. Look at manufacturer events, corporate client events. Breaking ground for a new complex at Turn 11 with indoor/outdoor space for hospitality.

We have the advantage of having a racetrack that is 12 miles from a top destination.

Cathy: Question about event center at Turn 11 – open for public rental, etc?

Steve: Total capacity 1,100 ppl. Caveat – use permit requires automotive connection. Aug 1 groundbreaking scheduled, open in the next Spring.

Wooly weeders will stay, but we also have some new cattle coming out there to graze.

Sonoma as a brand stays strong among NASCAR and other events – remains a draw for people looking for places to bring sponsors and do hospitality.

Look for some kind of announcement for the hospitality community about a chance to see the things at Raceway.
