Final transfer of this fiscal year went into SVVB marketing account. November TOT receipts this year were \$29,000 vs about \$56,000 year prior (2019) Recall November started out looking good but then we got a new stay at home order

2) Marketing update:

- The Stay at Home order came much faster than we had anticipated. We are focusing on outdoors and hiking and biking – did a collaborative video with Weekend Sherpa who has large exposure in SF and LA
- Now selling regional parks passes for Sonoma Valley Regional Parks
- Themes: visit in winter, food to go from restaurants, new video will come out showing why people should order direct from restaurants and not use GrubHub, etc
- Sacramento just moved out of lockdown and into purple tier, which wasn't based on actual ICU availability but a positive trend of it
- Plaza lights successful good appearance on social media lights come down on Jan 23. Doing a walk through with vendor for new ideas.
- We believe reopening of Sonoma County for leisure might be in mid-Feb hard to tell. We (along with Chamber of Commerce) ask the County on a regular basis.
- SVVB South Visitor Center moving to Viansa Winery in February
