Executive Director Laci Laperouse and Commissioners welcomed Jude Mequet, Owner of Team Voodoo Crawfish Tours. Mr. Mequet shared insights into his unique crawfish tour

experience. He discussed how he started the business and provided an overview of what guests can expect during the tour. Jude offers private, reservation-only tours that last approximately 1 to 1.5 hours. The experience is truly "pond to table," as visitors learn firsthand how to harvest crawfish. Guests participate in pulling up traps, emptying the catch, and rebaiting the traps, gaining a deeper understanding of the crawfish industry. He also demonstrates how to properly boil the crawfish and teaches guests how to peel and eat them, making it a full Louisiana culinary experience.

Prior to adjournment, Executive Director Laci Laperouse provided tourism updates to the Commissioners, presenting the events promotions budget along with websites, social media, and Constant Contact analytic reports, which will now be shared quarterly. She discussed her recent meeting with TCA Director Jeanne McBride regarding event funding and an upcoming meeting with Mayor Collette about utilizing hotel/motel tax revenue for tourism in Henderson.

She highlighted the success of the Pardoning of the Crawfish event on March 11 and shared insights from the FRVA convention she attended with Assistant Director Megan LeBlanc in Georgia. St. Martin Parish Tourism will also participate in the Parks Cracklin Cookoff for the second year in April.

Additionally, she announced an ongoing collaboration with LOT to host international travel writers for the Crawfish Festival. St. Martin Parish will also be involved in the IFTWA annual conference, with 10 travel writers visiting Maison Madeleine for a Secret Supper Night in partnership with Lafayette Travel. She briefly touched on the Culinary Trails Event, asking commissioners to start considering a chef to feature.

With no further business, Executive Director Laci Laperouse announced the next meeting will be held Wednesday, April 9<sup>th</sup>, 2025, at 4:30 p.m., at the St. Martin Parish Tourism Office, 601 East Bridge Street, Breaux Bridge.
