of McGee's, which began in 1932 by Mr. Claude McGee. In 2016, Atchafalaya Swamp Base purchased McGee's and it now also serves as the adventure trek to Evangeline Area Council, Boy Scouts of America. Each year the Swamp Base offers a camping and paddling adventure for youth in the Atchafalaya Basin. Ms. Collette informed that McGee's also provides locals and guests swamp tours three (3) times a day, seven (7) days a week. Executive Director Laci Laperouse thanked Ms. Katrina Collette for hosting today's meeting.

Executive Director Laci Laperouse provided updates to the Tourism and SMEDA office renovations, noting the hopeful move-in time will be by late October 2023. Ms. Laperouse also talked about the amazing success and feedback received from the Gator By The Bay Festival. Finally, Ms. Laperouse advised that the St. Martin Parish School Board has contracted with a company to identify short term rental properties and notifying the owners of the parish occupancy tax they should be collecting.
