1. Sponsor

The Sponsor in this Visit Tampa Bay Sweepstakes is Tampa Bay Convention & Visitors Bureau, Inc. d/b/a Visit Tampa Bay (“Visit Tampa Bay” or “Sponsor”).

If any such provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
