

The Cilurzo Winery of the Year Award 2019

The Cilurzo Winery Award of the Year recognizes a winery operating in the Temecula Valley, who routinely offers an exceptional guest experience through its wine, winery & vineyard quality and appearance, and philanthropic endeavors for the betterment of the community.

Nominating Committee

1. The nominating committee shall consist of five-members. Three members shall be appointed by the TVWA Board of Directors.
2. Two of the five committee members that are Winery Member Directors on the VTV Board, shall be sitting nominating committee members.
3. The nominating committee shall consist of TVWA Board Members, winery owners, or their representatives.

Cilurzo Winery Award Standards

Award Process:

1. Any winery that meets the Cilurzo Winery Award Standards may be considered for nomination by the nominating committee. Only the Nominating Committee can nominate.
2. Each nominated winery will submit their own narrative, describing how they best meet the criteria listed in the Cilurzo Winery Award Standards.
3. The nominating committee will select three wineries as finalists.
4. The committee will visit all three nominated wineries for a tasting and tour experience.
5. A third-party professional “mystery shopper” will be selected and hired by the CEO of the VTV with approval of the Nominating Committee. The “mystery shopper” will visit the three finalist wineries and will complete the “Award Questionnaire” and write a summary based on their experience. The 3rd party shopper will not be connected in any way to any VTV or TVWA Board Member, Nominating Committee Member, or any winery to ensure partiality.
6. The nominating committee will interview the three finalists.
7. The nominating committee will review the questionnaires/narratives and vote for the winner.

Dates:

- Winery Nominations: Opens Nov 1st-Dec 15th
- Submissions with narrative reports: Due by December 15th-Committee receipt: Week of Jan 21st
- Committee Appointments: by January 6th
- First Committee meeting Jan 16th review process
- Selection of finalists: by February 3rd
- Committee site visit February 4th or 5th
- Mystery Shopper and submission of reports to Nominating Committee: Feb 8th by 4:00pm
- Selection Committee Winery interview meetings February 11th or 12th
- Final Vote for Award winner: Feb 12th-15th by 4pm February 15th (or sooner)

Award Rules:

1. All wineries must be members of Visit Temecula Valley and the Temecula Valley Wine Growers Association as "Full Winery Members." "Provisional Winery Members" are not eligible.
2. A winery may be awarded no more than once during any five-year period (exceptions are subject to the authorized committee).
3. A committee member must recuse if his/her winery is considered for the award and will be promptly replaced with a new committee member to be selected by the TVWA Board of Directors.
