RTO5 Tourism Relief Fund (TRF) Program

Application Guide: Program Details and Eligibility

ALERT: Please do not submit an application if you have already applied to the Tourism Relief Fund through FedDev Ontario unless specifically instructed by FedDev to do so.

Overview:

The Tourism Relief Fund

https://www.feddevontario.gc.ca/eic/site/723.nsf/eng/02651.html?OpenDocument is a program of the Government of Canada that supports businesses by enabling them to invest in expanding and enhancin100%g visitor products and services.

Administered by the Federal Economic Development Agency for Southern Ontario (FedDev Ontario), the program is designed to help businesses and destinations recover from the deep challenges of the pandemic and build toward future, sustained growth.

In the regional destination encompassing the cities of Toronto, Mississauga and Brampton, the TRF is being delivered by Destination Toronto in its capacity as Regional Tourism Organization 5, in close partnership with Mississauga Tourism, the City of Brampton and the City of Toronto.

This guide sets out the details of the program for potential applicants. Eligible applicants can apply for a non-repayable contribution between \$20,000 and \$100,000 for up to 50% of eligible project costs for incorporated for-profit businesses and up to 100% of eligible project costs for not-for-profit organizations and municipalities. Costs may be eligible on a retroactive basis for up to 12 months prior to the receipt of a project application, but no earlier than April 19, 2021. Without exception, all projects must be completed by, and all project expenses incurred no later than, December 31, 2022.

All fully completed applications received via our online portal on or before Sunday, May 15, 2022 at 11:59pm ET will be considered for TRF funding. All applications will be reviewed and assessed at the same time, after May 15. Unfortunately, applications received after May 15, 2022 will not be assessed.

Due to the high volume of applications anticipated, not all application requests will be successful. Some applications may be awarded a lesser amount than requested in order for the TRF program to reach maximum breadth of impact across the region. In the case of a lesser awarded amount, the applicant will need to determine if project goals can still be achieved to meet any conditions of TRF funding approval and a RTO5 Business Liaison may be in touch with an applicant during the assessment process for your further input into the funding request.

It is important to please review the eligibility criteria below in full prior to applying to the fund.

Program Criteria:

Who is eligible?

Eligible Applicants

- Not-for-profit incorporated organizations (including tourism associations and destination management organizations)
- Incorporated businesses, primarily small- and medium-sized enterprises (SME's)
- Post secondary institutions
- Indigenous/First Nation/Métis owned businesses and organizations

Ineligible Applicants

As set out in the criteria from FedDev Ontario and the Government of Canada in the program design phase, businesses that are in the following industries are <u>not</u> eligible for participation in this program:

- Restaurants and restaurant chains
- Hotel chains
- Partnerships
- Sole proprietors*
- Retail sector businesses

Exception: Indigenous sole proprietors are eligible

<u>Note 1:</u> Independent businesses operating in the restaurant, hotel and retail sector <u>may</u> be considered for funding if they are an anchor product and the main reason for attracting visitors to the region. This will be assessed on a case-by-case basis.

<u>Note 2</u>: If you are an eligible applicant whose operations reside outside of the RTO5 region, applications for the Tourism Relief Fund are available in your region. To check which regional office is accepting applications on your behalf, see

Are you an Indigenous owned and controlled business?

The destination partners in Toronto, Mississauga and Brampton (RTO5) are proud to work in partnership with Indigenous Tourism Ontario (ITO) to deliver the Tourism Relief Fund in support of Indigenous tourism in the province of Ontario.

Program Objectives of the Tourism Relief Fund:

***Writing Tip: The information in his section of the Application Guide, including touching on as many federal and regional priorities as possible and/or having a significant impact on one or two priorities is vital to incorporate into your submission).

The program seeks to enable ultimate recipients to strategically adapt projects and services to adjust to changing public health requirements, while planning for and investing in recovery efforts for future growth. It will also empower tourism entities to seize new market opportunities while helping the visitor economy sector reposition itself for both domestic and international visitors as the country safely reopens.

Specific objectives are:

• Supporting those costs related to product development and enhancement of the visitor experience to help tourism businesses adapt to the 'new normal',

modernize tourism offerings, and encourage the adoption of more environmentally sustainable practices; and,

 Supporting destination development so that it positions our region to take advantage of post-pandemic opportunities through strategic planning for medium to long-term investments, as well as supporting destination development in line with objectives set out in the Federal Tourism Growth Strategy and projected through the RTO5 regional priorities.

Federal Government Priorities for the Tourism Relief Fund:

As the Tourism Relief Fund in funded by the federal government, priority consideration will be given in the scoring evaluation to those applications with projects that address one or more of the following federal priorities:

- Support the Indigenous tourism sector
- Are led by a business/organization of strategic importance to the tourism sector in the region
- Contribute to the economic development of a region
- Contribute to job creation in the region
- Take place in a tourism-dependent community/region, including projects supporting downtown cores, and
- Are led or majority-led by persons of underrepresented groups: women, Indigenous peoples, members of Official Language Minority Communities (OLMC), youth, persons with disabilities, newcomers and immigrants, black communities, racialized communities, and LGBTQ2.

RTO5 Regional Priorities for the Tourism Relief Fund:

Priority consideration will be given in the scoring evaluation to those applications with projects that address one or more of the following regional priorities:

- Support the underrepresented stories and experiences in our communities, including Indigenous and equity-deserving communities;
- Support the sector's small businesses;
- Expand destination appeal and experiences that have the potential to drive growth in visitation in the winter season;

- Facilitate workforce development and promote the employment for youth and newcomers in the sector;
- Facilitate the recovery of business travel (both group and transient);
- Advance accessibility of tourism and hospitality businesses;
- Augment environmental sustainability;
- Support businesses and neighbourhoods also adversely affected by long-term infrastructure work and construction; and
- Elevate destination appeal through Placemaking and public art.

What types of projects qualify for the program?

Qualifying projects could include:

- Creating, adapting, and enhancing protocols and permanent infrastructure to meet health and safety requirements to accommodate visitors;
- Modernizing operations, attractions, greening initiatives, and online sales services;
- Developing capacity for more inclusive tourism experiences to ensure welcoming, inclusive environments to diverse clientele,;
- developing sustainable community tourism plans based on research and market analysis, and designed to rebuild tourism confidence in communities;
- Supporting seasonal dispersion by equipping tourism SMEs to extend their product offering to increase visitation during the winter and shoulder seasons;
- Implementation of tourism plans that create or improve local assets, facilities, and planning for key infrastructure;
- Developing and enhancing tourism services and experiences; and,
- Implementing strategies to re-activate and animate downtown cores, main streets and business districts through activities, public art, and mixed-use spaces.

Other Important TRF Eligibility Information:

- Only one application per business/organization is allowed to ensure we are able to reach as many businesses as possible with the available TRF funds
- Applicants must be incorporated (Note: not applicable for Indigenous businesses/organizations)
- Applicants must be able to procure and provide proof of commercial general liability insurance of at least \$2,000,000, once approved
- Applicants must be registered for HST

- Applicants must submit financial statements for the most recent two years (in cases where applicants are a new business, all available financial statements and/or a solid business plan must be provided)
- Applicants must have evidence to support their budgeted project costs.
 (eg written cost estimates, quotes)
- Applicants are able to make use of other federal funding towards the specified activities contained in their funding application, but these may not overlap with TRF funds.
- Applicants must be in full compliance with all applicable government laws, rules, regulations, guidelines, and other legally binding measures (Laws).
- Applicants must be financially viable and plan to continue to operate or resume seasonal operations.

Ineligible TRF Project Expenses:

By way of example only, ineligible project costs include, but are not limited to, the following:

- costs of land, building or vehicle purchase;
- Refinancing;
- costs of intangible assets such as goodwill, whether capitalized or expensed;
- depreciation or amortization expenses;
- interest on invested capital, bonds, debentures, or mortgages;
- Bond discount:
- losses on investments, bad debts and any other debts;
- fines or penalties;
- costs related to litigation;
- non-incremental wages;
- fees for administrators, including payments to any member or officer of the Recipient's Board of Directors;
- opportunity costs;
- hospitality and entertainment costs;
- costs of individual membership in a professional body (e.g. professional designations);
- lobbyist fees; and
- gift cards.

Note: No expenses incurred prior to April 19, 2021 will be accepted.

Application Evaluation Process:

Submitted applications will be assessed by an Evaluation Committee including representatives from Destination Toronto, Mississauga Tourism, the City of Brampton and the City of Toronto. The application will serve as the basis for the evaluation.

The application evaluation process will include a fair and consistent evaluation of the merit, impact and viability of submissions against standardized evaluation criteria. As noted in the guide, priority consideration will be given in the scoring evaluation matrix to those applications with projects that address federal priorities and established RTO5 regional priorities. All recommended applications and the allocation of funding amounts will also be vetted by FedDev Ontario to approve.

Unfortunately, applications that fail to meet eligibility requirements or are incomplete when received, will not be considered for TRF funding.

<u>Please note that all decision results are final. There is no appeal of the TRF Evaluating Committee's recommendations regarding funding allocations.</u>

Requirements for Successful Applicants:

Fund Disbursement:

- Upon awarding of TRF funds, applicants will be required to enter into a formal Funding Agreement defining the terms of payment and the obligations of the parties.
- RTO5 will disburse funds to successful applicants as follows:
 - Sixty-five percent (65%) of funds to be awarded upon signature of the Funding Agreement

 Remaining payment of thirty-five percent (35%) of awarded funds upon completion and approval of the Final Report to be received within 30 days of project completion.

Itemized List of Approved Claim Summary Deliverables:

 All successful applicants will be required to submit an itemized claim summary of eligible project costs incurred, along with a certification of the claim by a director or officer of the business/organization, confirming accuracy of the claim as part of their Final Report.

No expenses incurred prior to April 19, 2021 will be accepted.

Applicant Report Submission:

Successful applicants will be required to submit the following reports:

Status Report – All non-retroactive projects (i.e. projects with an End Date after September 31, 2022) <u>may be asked</u> to complete a brief Project Status Report due August 31, 2022.

Final Report – This will include a brief summary of how the awarded funds were used, including a synopsis of how the project helped to create and/or maintain jobs and improve the visitor experience. A template will be provided.

Key Dates:

April 22, 2022. RTO5's Tourism Relief Fund online application, funding criteria guide and Frequently Asked Questions (FAQ's) are live and applications are being accepted.

<u>Note:</u> Participating in either the webinar or talking 1:1 with one of our Business Liaisons concerning your application is <u>optional and does not affect</u> the evaluation or decision process.

May 15, 2022 at 11:59PM. Application Portal Closes. No further applications to the RTO5 Tourism Relief Fund will be accepted after this time.

June 13th to June 24th. During these 2 weeks, all applicants will be advised of their application results.

June 13th to July 31st. Successful applicants will be invited to enter into a funding agreement and when any conditions of approval are satisfied (eg..confirmation of our receipt of minimum \$2Million liability insurance OR a sales quote on work or a large purchase to be completed OR other essential funding sources to be confirmed to make your event viable OR municipal community councils approve an event, etc), a first advance will be generated.

December 31, 2022. All projects to be completed by, and all project expenses incurred no later than this date.

January 31, 2023. Final Report Due for those programs that finished on the last day of the 2022 calendar year.

Frequently Asked Questions

What if I've already applied to the Tourism Relief Fund through the Federal Economic Development Agency for Southern Ontario (FedDev Ontario)?

You can only make one application per organization to the Tourism Relief Fund.

Can a business/organization submit multiple applications?

No. Only one application per business/organization is allowed to ensure as many applicants as possible are able to take advantage of the RTO5 Tourism Relief Fund throughout the entire duration of the program, even if you applied last year and were unsuccessful.

When will I know if our application was successful?

Applicants can expect to be notified starting mid-June if their application was successful. All applicants - successful and unsuccessful - will receive a communication to inform them of the decision.

Our main operating company is a limited partnership, but we do have a general partner that is an incorporated company that owns the partnership. Do we submit the application under the general partner incorporation number?

The limited partnership would be connected to the project but the applicant would be the Incorporated company.

Can I submit a paper-based application rather than through the online application portal?

No. Only applications submitted electronically will be considered. If you are having difficulty, one of our RTO5 Business Liaison Specialists listed below would be happy to assist you.

NEW FAQ's! (added May 5, 2022) The RTO5 team hopes you find the following FAQ's helpful.

I can't afford to do this project unless I am successful in my application for funds. What should I do?

We recommend that you do not expend any funds prior to your project being accepted and you are able to meet any conditions to be outlined in your Contribution Agreement. Note that all applicants will be advised of their approval or decline status by mid-June with first payments in July advancing 65% of your approved funds.

I've been wanting to expand my facility for a long time – could I do that through this fund?

Funding is intended for projects that meet the spirit of the guidelines and applications for the RTO5 Tourism Relief Fund as determined by FedDev Ontario.. Please review the applications and guidelines to determine if your project is eligible and contact your RTO5 Business Liaison Officer at trifinfo@rto5.com with any residual questions.

Would we be eligible as a registered charity?

If the registered charity is an Incorporated Not-For-Profit, you would be eligible.

As an artist/musician or specific tourism festival/event management company, am I eligible for this fund?

As an individual artist or musician, no. Although not specifically listed, in some instances the above may be eligible if individuals or entities are incorporated as a business that meets all other eligibility criteria.

What is a "key supplier or operator in the visitor experience"?

For the purposes of this program, a "key supplier or operator in the visitor experience" is defined as one that provides the infrastructure and services necessary to support a tourism economy, connects tourism products to potential markets, leads planning for sustainable destination development and supports capacity building/skill development in the sector. In general terms, it would be generally accepted and easily proven that your organization is a tourism-leading organization that positively impacts the regional visitor economy by building destination development.

I am seeking more than \$100,000, can I still apply for the HHB Regional Tourism Relief Fund?

No. The RTO5 Regional Tourism Relief Fund is capped at \$100,000 per application. If you are seeking funding over \$100,000 in contribution, you must apply directly on the FedDev Ontario website. We can make introductions for you. When applying to FedDev Ontario for larger gifts, be aware that funding conditions and timing of approvals are different from the modified RTO5 Tourism Relief Fund. If my project was started last year and is finished, can I still apply for funding?

Yes IFyour project meets the eligibility criteria as outlined in the application guide and your eligible project expenses started on or after April 19, 2021. Eligible expenses dated after April 19th, 2021, can be remitted providing support documentation is included as part of the financial report. More information on

disbursements will be provided when your application is approved and terms of funding approval provided.

What is an N.A.I.C.S. code and where do I find out what my code is?

The North American Industry Classification System (NAICS) is the standard used by federal statistical agencies in classifying business establishments for the purpose of collecting, analyzing, and publishing statistical data related to the business economy. I am receiving/have received other COVID-19 related government funding to support my project. Can I still apply to TRF?

Yes. but as long as the other government funding received for your TRF project is not from FedDev Ontario. You are able to make use of other government funding sources towards specified activities contained in your funding application . However, any of these sourced funds cannot overlap with TRF eligible expenses. (i.e. you cannot 'double dip'). All applications are vetted for source of funds and, unfortunately, any violations in relation to this criteria will result in automatic cancellation of your application and FedDev Ontario may require your business to pay back any awarded and spent TRF funds and take further action as required.

What are the "applicable government laws, rules, regulations, guidelines and other legally binding measures (Laws)" that the Applicants must be in full compliance with?

In plain terms, all applicants confirm in their funding request that they operate "above board" in all matters, operate in accordance with municipal by-laws, provincial and federal laws, and that they are respectful of regulations and best practice guidelines in their industry and the visitor economy.

I would like to use TRF funding to cover marketing expenses. Is that permitted/eligible?

Marketing and promotional expenses are typically <u>not</u> eligible for any TRF funding. It would be rare to award any marketing dollars as eligible expenses. Any exceptions would be evaluated on a case-by-case basis.

The Application:

Applications will be accepted until Sunday May 15th, 2022 at 11:59 pm ET.

- The fillable online application is a Google Forms document. Only Google Gmail
 users will be able to start, stop and save the application and then return to the
 application later without losing any data entered.
- Non-Google Gmail users will be unable to save the document at any time prior to submission. Any data entered on the application will not be saved if you close the application prior to submission. We recommend either:
 - 1. Using your Gmail address (or opting in for creating a Gmail address) for the application submission, OR
 - 2. Print off the PDF version of the <u>Application Worksheet</u> so you can review all questions, write your answer content offline at your own convenience, and then complete our online application via copying and pasting your longer text responses directly on the Google Forms application form when you know that you can complete the application uninterrupted.
