11. Outreach Update

- The Washburn County Kiosk was in Shell Lake for the Fine Arts Festival, the next planned event to bring that to is Stone Lake Cranberry Festival.
- Kaitlin is arranging business tours for the Tourism Team.
- Kelsy & Kaitlin attended the Shell Lake Chamber Events & Marketing committee to discuss the 2024 Washburn County Guide and room tax dollars. They will plan to meet with them again in September.
- Membership mailing went out. Kaitlin will be emailing current Platinum Members to let them know
 they have first right of refusal for those limited spaces. Membership will continue to be a large part
 of the outreach in the coming months.

12. Operational Update

- Travel Information Center Grant: WCTA did not receive any money from the July round of the TIC
 Grant. Kaitlin spoke with Heidi to ask for any feedback for future applications, she was told this
 was the most competitive round of this grant and this grant program has the least amount of
 dollars to distribute. The largest hinderance is not having staffed weekend hours even though we do
 have the 24-hour information kiosk & video doorbell to reach staff.
- Staffing Contracts: Rodeo This was a record year for the rodeo selling out of ALL three nights and having very minimal tickets to sell at the gate for Thursday evening. Friday & Saturday were sold out prior to the tickets leaving the tourism office. Spooner Rodeo is changing their ticketing program moving forward. Kaitlin has already supplied the ticket company with the information needed for them to start creating the event. Ticket sales will begin on Monday, October 2nd. Staff will have a few trainings before that to learn the new ticketing program.
- Staffing Contracts: Cranberry Fest Vendor spaces are filling in. There will be a larger mailing to vendors with their confirmation information going out at the end of the month. Going very smoothly thus far.
- Audit committee met back in June & completed their report. Available for anyone interested in that. Thank you to Joe, Ann Miller & Dave Wilson for taking time to help with that this year.
