Frequently Asked Questions (FAQ's)

Why are you asking for the rights to my photo/video?

Because we love the photo/video you took! And we hope you'll allow us to potentially share it with the world to inspire people to visit the Lafayette–West Lafayette area.

Where and how will you use the photo/video?

We may just be looking to share the photo/video on our Instagram feed. Other places we may use the photo/video include but are not limited to our social media channels (including Instagram, Facebook and Twitter)—in both organic and paid posts—, here on HomeOfPurdue.com, our travel guide, and print and digital ad placements. For a more detailed list of all possible usage, please see below "Non-Confidentiality."

Why do you say "potentially share it" and not "definitely share it"?

Marketing plans can evolve and we may not use it where we originally had in mind or we may use different content in a placement instead.

Will you let people know it's my photo/video?

We'll do our best whenever possible to give you credit by displaying your username, name, or image when and where we can, but a limited number of placements may not allow for it. We will as often as we can, though.

Will you edit my photo/video?

Some placements may require us to crop the photo/video to better fit in the display dimensions or otherwise make changes, but we'll always try to keep the editing to a minimum. You took a great photo/video and we don't want to mess with it!
