### OFFICIAL RULES FOR CAROLINA BEACH GETAWAY GIVEAWAY

# 1. Sweepstakes Description

Two (2) grand prizes (estimated value of \$520 each) described in Section 5 below will be awarded based on a random drawing each day of eligible entries received that day during the Entry Period. This Sweepstakes is void where prohibited and subject to all local, state, and federal laws and regulations.

# 2. Eligibility

The Sweepstakes is open to legal residents of the United States of America, age twenty-one (21) or older. On or about April 1, 2024, a random drawing will be conducted by Sponsor from among all eligible entries received by Sponsor to select the potential Grand Prize winners. If a potential winner does not respond to the notification or cannot be reached within forty-eight (48) hours of the initial communication, any notification is returned as undeliverable, or any Documents specified in Section 7 below are not returned within forty-eight (48) hours of receipt by the potential winner, the potential winner may be disqualified in the sole and absolute discretion of Sponsor and an alternate potential winner randomly selected from the remaining eligible entries.
