IV. Secretary's Report

a. Budget Update

Secretary Meaney addressed Governor Evers budget and gave a high-level overview of the specific ways the budget may impact the Department of Tourism.

b. Strategic planning process

Secretary Meaney noted that a lot of progress has been made on the strategic planning process since the Council last met and were briefed on the topic. To date, Tourism has selected Coraggio as their consulting partner who came highly recommended by many on the National Council of Travel Directors. The strategic planning team held its first kick-off phone call with Coraggio and will continue to work with them to reach the ultimate goal of developing a plan that will support a thriving Wisconsin Tourism Industry. The team is eager to assess what needs to do to keep moving forward to build on the current progress of the Department.

Throughout the strategic planning process there will be frequent opportunities for stakeholder engagement through the collection of data. The team will ensure that the vision ahead of the Department is clear; evaluate the future state that we are trying to create for Wisconsin Tourism; determine our mission; determine our brand intention; and prioritize what we are trying to make

Secretary Meaney explained that Council members will be invited to participate in an online survey to collect a broad sample of priorities from across the state. Coraggio will also lead stakeholder listening sessions so there is an opportunity to ask questions. Details will soon be made available.

Secretary Meaney introduced Cree Lawson from Arrivalist. Cree walked Council members through a data set and talked in detail about how decisions can be informed by data. Cree also spoke about the work Arrivalist has currently been doing with the State of Wisconsin to track visitor movement.

Paul Upchurch announced that last week, Milwaukee was selected as the host city for the 2020 the DNC. Paul noted that the DNC will be held in early to mid-July, bringing a lot of families to our state looking to spend vacation time.
