## State of Tourism

It is predicted that 2024 will be a record-breaking year for the global travel industry, with the industry expected to contribute \$11.1 trillion to the global economy. The state's investment in this industry by way of a base budget increase of \$1 million per year and the one time funds of \$29 million will directly yield more tax revenue for our state.

We can measure the direct impact of our 2022 summer and fall campaign ads which resulted in an additional 1.9 million trips. Those trips accounted for \$290 million in spending. For every advertising dollar Travel Wisconsin spent in 2022, a new visitor spent \$31.

#### Program Updates

The momentum of Top Chef continues. There were 1,963 media mentions about Top Chef Wisconsin from local and national outlets, resulting in 14.15 billion impressions over a 10-day period before and after the premiere. As the season continues, awareness of Wisconsin will continue to grow.

The annual Wisconsin Governor's Conference on Tourism was very impactful, providing excellent programming and networking opportunities for 781 attendees. WIGCOT 2025 will be hosted in La Crosse.

Secretary Sayers shared that the Department is in the process of both a Marketing and Public Relations RFP. The Department is also persistently working on hiring following the recent announcements of two Department retirements, and is committed to building stability and experience into the organization for the long term.

## **Budget**

The next biennial budget is around the corner, and Secretary Sayers reminded Council members of how much of our current work and successes are made possible by one-time funds.

## VI. Election of Officers

Mary McPhetridge provided a review of the election process as established by Council bylaws. Nominations submitted ahead of time as allowed in Article IV, Section 5 of the bylaws were included in the vote. All members of the Council were able to make nominations. Voting was held by roll call voice vote.

## VII. Election of Marketing Committee Member

Mary McPhetridge provided a review of the Marketing Committee as established by Council bylaws. Following the recent departure of Michelle Martin from Council, the Marketing Committee had one vacancy to be filled by a Council member, by vote of Council.

The floor was open for nominations. Council Chair Ben Popp nominated Aaron Sherer. Mary McPhetridge nominated Krystal Westfahl. Aaron Sherer declined his nomination. There were no further nominations. Roll call votes were taken; Krystal Westfahl received 13 votes and was elected to the Marketing Committee.

Following discussion, the Council unanimously preferred to convene for the next meeting of the Wisconsin Council on Tourism in the fall.
