- 1. Pledge of Allegiance;
  - Led by Chairman Brad Bailey
- 2. Call to order and adoption of Agenda;
  - The meeting was called to order at 8:32 a.m., and a motion to adopt the meeting Agenda passed unanimously.

Motion by Vice Chairman Fred Domenick, seconded by Secretary/Treasurer Richard Franks

- 3. Public Comment;
  - None.
- 4. Receive, consider and act upon the recognition of Vice Chairman Fred Domenick's Retirement;
  - Board members and staff congratulated Mr. Domenick on his retirement from The Woodlands Waterway Marriott as General Manager.
- 5. Consider and approve Minutes from the Special Board Meeting on May 17, 2023;
  - Motion to approve the Minutes as read passed unanimously.

Motion by Secretary/Treasurer Richard Franks, seconded by Director Linda Nelson

- 6. Receive, consider, and approve the Financial Report through May 2023;
  - Kellan Shaw, Township Director of Finance, delivered the Financial Report. At the end of May, actual revenues totaled to \$1,456,672 compared to a \$1,239,681 budget, resulting in a favorable variance of \$216,991. The Supplemental hotel tax revenue showed a favorable variance of \$93,023, and there was also a favorable variance in operating transfers of \$112,788. The favorable variance in operating transfers related to the Township transferring more supplemental tax to Visit The Woodlands than budgeted due to expenditures being higher than budgeted due to timing.
  - The Actual Expenditures at the end of May totaled \$1,456,672, compared to budgeted expenditures of \$1,239,681. The unfavorable variance of \$216,991 is primarily attributed to timing differences of line items within the budget.
  - As of May 31, 2023, the undesignated fund balance for Visit The Woodlands was \$1,235.799.
  - Motion to approve the Financial Report through May 2023 passed unanimously.

- 7. Receive, consider, and act upon an update on Staff Initiatives;
  - President Nick Wolda told the Board that the next issue of #SoWoodlands was sent out and to be expecting it in the mail. He also mentioned that the RFP for Design Purposes and Media Buying is posted for bids.
  - Josie Lewis, Director of Sales, stated The Woodlands will be hosting 400 people from the Texas Society of Association Executives in 2024 at The Woodlands Resort. She and Elizabeth Eddins attended the Texas Firefighters Association conference in El Paso for a bid presentation to bring the conference to The Woodlands in 2025, which was won. Ashley Fenner will be attending CVENT Connect in July. Julie Quinn has been busy keeping up with multiple servicing requests happening until the end of the year.
  - Motion to approve Staff Initiatives passed unanimously.

  - President Wolda announced that Visit The Woodlands is working on holiday packaging with hotel properties.
  - Chairman Bailey mentioned that he has been working with Township staff on new projects and events for the holiday season and having Visit The Woodlands play a role in enhancing holiday attractions.
  - Motion to allot \$150,000 from Visit The Woodlands fund balance to use towards holiday activaties and economic stimulus passed unanimously.

  - President Nick Wolda congratulated Fred Domenick on his retirement from The Woodlands Waterway Marriott and for his participation on Visit The Woodlands Board of Directors. He also congratulated Julie Quinn, Sales & Servicing Specialist, on becoming a United States citizen.
