 - NOTE: If filming involves the use of pyrotechnics, explosives or fireworks, then \$3,000,000 per occurrence, \$3,000,000general aggregate.
- 6. **Liquor Liability Insurance:** If alcoholic beverages are sold, served or otherwise made available, then, Liquor Liability Insurance with minimum limits of \$1,000,000 each claim.
- 7. Umbrella Policy Insurance as required.
