Get your taste buds ready and bring your appetites! Restaurant Week SC makes a much-anticipated return January 10-20, 2019. The 11-day food fest allows diners to experience all that the area's culinary scene has to offer. This year's campaign is particularly special, as the [South Carolina Restaurant & Lodging Association](#) (SCRLA) is celebrating the ten-year anniversary of Restaurant Week SC! For the second consecutive year, [Visit York County](#) and the [Olde English District Tourism Commission](#) (OED) are partnering with the SCRLA to host Restaurant Week York County.

Around 250 restaurants from across the state will offer special prix fixe menus showcasing the best of their cuisine and special dishes. In the York County area, 6 restaurants (9 locations) are part of this year's campaign.
