### **Your Restaurant Agrees to:**

- Offer a menu for breakfast, lunch, and/or dinner or all-day that can range in price points from \$10 up to \$55 increasing by \$5 increments. Simply pick your price point and execute a great dish at a great deal – include multiple courses, wine, beer, or cocktails, even dessert if you like. Price excludes tax and gratuity.
- The price point selected must provide a value to the customer. All participants must stay at the stated price points and not add any up charges in order to preserve the value and reputation of Restaurant Week.
- By October 1, 2022 (if not earlier)
  - Submit the Participation Agreement
  - Include payment of \$25.00
  - Provide Restaurant Week menu(s) and restaurant logo (.jpg format)
  - Provide a \$25 gift certificate for promotional use
  - Display Table Tent Cards on each table and poster in window prior to the start of Restaurant Week (optional)
  - Provide basic transaction information to Chesapeake CVB following the event for use in an economic impact analysis of Chesapeake Restaurant Week. A general reporting form will be provided to participating restaurants to fill out and return.
