JPA - VGPS BOARD OF DIRECTORS JOINT MEETING MINUTES DATED December 13, 2024 (all vote)

The JPA Executive Committee and VGPS Board of Directors Joint Meeting Minutes dated December 13, 2024, were presented for approval. JPA Chair Fermon asked for changes or abstentions. No changes or abstentions. JPA Chair Fermon asked for a motion. Gary Gardner with the City of Desert Hot Springs

made a motion to approve. Linda Evans with the City of La Quinta seconded. No abstentions. There was no further discussion, and the minutes were approved based on the roll call at the beginning of the meeting.

1. Warrants and Demands Dated December 2024

The Warrants and Demands dated December 2024 for Pacific Premier Bank were presented for approval. JPA Chair Fermon asked for changes or abstentions. No changes or abstentions. JPA Chair Fermon asked for a motion. Linda Evans with the City of La Quinta made a motion to approve. Steve Downs with the City of Rancho Mirage. seconded. The Warrants and Demands were approved based on the roll call vote at the beginning of the meeting.

PUBLIC COMMENT - TOURISM BUSINESS IMPROVEMENT DISTRICT (TBID)

TBID Public Comment period

Davis Meyer addressed the room.

The city of Coachella joined the Joint Powers Authority last year. In order to include lodging properties in the city of Coachella in the GPSTBID, we need to modify the current district to expand the boundary into the city of Coachella. That process began last board meeting on December 13, 2024, when the JPA passed the resolution of intent. Following the passed resolution of intent, there are two public meetings. The first meeting is this one, and the next one is the next board meeting on April 4, 2025. Assuming no majority protests, there will be a resolution to affirm the modification and the city of Coachella lodging properties will be added to the TBID starting July 1, 2025.

Davis asked for questions:

- Linda Evans with the City of La Quinta asked if we will have a reporting process in place to accurately report the TBID assessment for the City of Coachella by the July 1st date.
 - Davis Meyer responded, "Yes, we have worked with the City of Coachella staff to establish that process. This is the same process for the other cities."
- Dr. Frank Figueroa commented that he appreciates the positive language in the letter we sent out notifying vacation rental holders.
- Sarah Goslin with Visit Greater Palm Springs, Clerk of the Board, stated that they had 3 public protests on record.
- Scott White asked for public comment.
 - No members of the public gave comment.

Public comment period for the TBID was closed.

CEO / PRESIDENT'S REPORT

Scott White:

- Thanked Gary Gardner for his service as our JPA Chair and presented him with a framed desert photo and signed card.
- Welcomed our new JPA representatives and alternates.
- 3. Visit California has seen major decline in visitation to Southern California from the fires in Los Angeles, which could potentially impact us as well. They're continuing to now emphasize that Southern California is open for business.
 - Airbnb has a program to sponsor individuals displaced from the fires and help them
 with temporary residences. We provided \$120,000 to sponsor the program. The goal is
 to apply those funds to vacation rentals in the Coachella Valley, but we left it up to
 them to decide who was most in need.
 - The LA Fire Relief landing page went live on January 9th with information on local special accommodations, rates, offers, and air quality updates. VGPS is trying to raise additional dollars for the American Red Cross and will match up to \$100,000. Thanked

the Board for giving us the opportunity to do that. The QR code can be found on our website for donations.

- 4. Desert Horse Park is a must-see venue and Desert Circuit is a wonderful tournament that we are proud sponsors of.
- 5. VGPS was awarded with the 2024 Fired Up! Cultural Achievement Award.
 - We work with Fired Up Culture throughout the year, and every 2 years they send out an organizational survey to all staff. The questions are about how the individuals think our company is performing from culture to processes. Our 2024 survey came back even more positive than 2023. The cultural achievement award is awarded to the company that really sets the standard amongst its peers when it comes to how engaged their team members are feeling about their workplace culture.
 - We take the results from the survey and work on any low scoring areas. This year's
 survey shows processes as our lowest score, which is still a high score overall, so we plan
 to continue educating and better training our staff on the many processes we have in
 place.
- 6. In 2024, four new flights were added and ten airlines either enhanced or started service earlier in the season.
- 7. Visit Greater Palm Springs hosted 24 top-tier clients for a FAM during the Palm Springs International Film Festival.

We also hosted 16 airline network planners during Airport Roundtable, a lot of which had never been to the destination.

Go West Summit was also hosted in January with over 400 attendees.

- 8. The 2025-2027 Priorities were presented with a note that we can make changes down the road, if needed. These allow our staff to build their goals and objectives for the year understanding you've set these as your priorities.
 - a. Increase demand with off-peak emphasis
 - Expand initiatives for need period (June-September) to include shoulder months (May and October-December) & develop programs to drive demand for these time periods
 - o Focus on the development of an indoor sports complex and overall sports strategy to attract new sporting events, especially during the need periods.
 - We will ask this group to form a task force to explore a sports improvement district to hopefully make an indoor sports complex a reality in the future. The Berger foundation would like to lease the land, but we need someone to help with funding.
 - b. Regional collaboration and economic diversity
 - Grow regional initiatives to include expanded workforce development and advocate for infrastructure support
 - o Launch the new economic development web site and campaign
 - c. Destination Stewardship
 - Develop strategies around sustainability, cultural heritage, accessibility, community engagement and advocacy.
 - Workforce Development strategies include rebranding the Tourism Foundation and expanding the Board in the future. Moving forward, we're going to do a workforce analysis program, continue to advocate for housing, and launch Team GPS 2.0.
 - We are only two hotels away from becoming a Autism Certified Destination.

Colleen Pace presented the Marketing 2024 results and 2025 goals.

Todd Burke presented the PR/Communications 2024 key achievements and 2025 goals.

Carolina Viazcan presented the Convention Sales 2024 results and 2025 goals.

Davis Meyer presented the 2024 results and 2025 goals for the following priorities: Economic Development, Workforce Development and Tourism Foundation, Stewardship, Vacation Rental Resources and Development, and Advocacy and Partnership.

- Brian Penna with the City of Indian Wells

 - o Indian Wells City Council passed a gift to Living Desert in the amount of \$500,000.
