They leave their Lund permanently docked on the launch ramp at the end near the fish cleaning station. Today was king salmon fishing opener. No one could dock and use the fish cleaning station because their boat was there unattended. Leaving their boat there also makes it more difficult for people to launch and load at low tide or when it is windy, as it was today. They did this all last year as well. I can't use the boat launch as a private dock, why can a non-locally based tourist operation? I'm not against the kayakers using the cove. It's a beautiful view and I'm happy that tourists can have that experience. What I am against is an operator who thinks he owns the boat launch, to the detriment of Juneauties. Last year when I asked them to move the Lund they refused. Today I couldn't even find anyone to talk to. Coastal Helicopters, Northstar Helicopters	NORTHSTAR HELICOPTERS TO EMAILER: ****, Thank you for using the TBMP hothine. The routing in and out of the airport environment is regulated by the air traffic control tower through a letter of agreement. We would know pretty quickly if any of our aircraft were not adhering to the flight pattern requirements and so far this season there have been no reports from the tower for NorthStar. Having flown with NorthStar for the last 26 years I'm keenly aware of our impact to the folks living on Radcliffe, La Parouse, and Bemers. Our location on the airport puts NorthStar's aircraft at a lower altitude when transiting the area near these streets. We have done everything we can over the years to reduce this impact including our requests to the tower to fly "opposite flow" in order to stay on the most southerly track possible. We also have resisted efforts by the tower to alter the helicopter traffic pattern in that corner by "straightening" out the downwind leg. The pattern we have created in our letter of agreement is unusual in that the racetrack like pattern is notched in that comer specifically to remain over airport property and as far away from those neighborhoods as we can. We don't have any green buses, but we can do a GPS track for the area yesterday and see if any of our white buses were driving as slow as reported. Speed increases the closer you get to the Allen Marine turn off, so shouldn't have been any reason to drive 20 the whole route. I picked three points along this stretch of road and did GPS proximity searches on all three for yesterday and I didn't find anyone who was consistently doing 20 mph. The slowest vehicle was doing 29 mph just after the Legion hall, but he did accelerate to 40ish before the rock quarry. This may have been ACT, but also an exaggeration. I've noticed that as soon as they pass Fisherman's Bend traffic ramps up to 50 mph pretty quickly in that area – well above the posted speed limit. In the absence of that, can they figure out how to shut the engines down more frequently so that the residents don't have to listen to that disturbing noise every day of the week? Northstar Helicopters	NORTHSTAR HELICOPTERS TO TBMP: The base we operate at the North Douglas heliport services two separate partners who have their bases on the south end of the Juneau Icefield. If that operation were to move to the airport more homes would be exposed to noise due to the further flight and altered flight path. There is currently no infrastructure at the airport that could support that operation regardless. All of NorthStar's flights shutdown between tour flights, they do not "keep the rotors on continuously". This is actually less efficient and is an added cost to NorthStar but we do shutdown for the safety of our guests, pilot comfort, fuel savings, and for noise abatement for the nearby neighborhoods. Northstar Helicopters	that this drill would take place. NORTHSTAR HELICOPTERS TO EMAILER: ****, Thank you for sending your concern via the TBMP system. My name is Jason Kulbeth and I'm the Director of Operations for NorthStar Helicopters. I'll start by answering your question, No we have not changed any of the routes in that area or from our base on North Douglas. They are the same routes that have been in place for 20 plus years from when ERA helicopters operated that base. One exception in our operation is that when the weather allows we utilize the "Salmon Creek" departure and arrival more than ERA did which serves to eliminate any noise issues for Douglas and downtown. This season so far we are down in flight numbers and passengers flown year over year from 2023. Currently we only operate 4 aircraft from the North Douglas Base which services our partners on the southern end of the Juneau icefield and Taku river. In 2018 and 2019 (first two years NorthStar operated on North Douglas) we flew 5 aircraft from that base, and at times before that ERA operated up to 12 aircraft from there. The routes have not changed but with that said there are things that can affect the perception of more noise or more traffic, weather being the chief among these. Also every season we end up with a handful of new pilots who are still learning the intricacies of the routing, weather, and noise sensitive areas. If you could send me specifics of time, location, number of helicopters, color of helicopters, direction of travel, your interpretation of what is being done improperly, I can more easily check to be sure that our pilots are adhering to the routes as specified or at least find out why they had to deviate. Also there is significant utility work being done by other companies down in the Annex creek area which could be contributing in part to some of the downtown area traffic. However, properly operated, the wakes at either side of Auke bay should be inconsequential. We did a study from a dock on the fritz cove side, and the wakes thrown by Orca Odysea (our largest vessel) were insignificant, even when we operated dramatically closer than any track on our GPS. We would be happy to replicate the study on your side as well. Orca Odysea has been operating in Auke Bay for a very long time, and although it is one of the more distinctive vessels, it is not the largest any more. We will be happy to come out to your dock and track all whale watching vessels with you at a time of your choosing so we can see which wakes (if any) are causing your problems. We appreciate input in order to make changes for the better. 4 mph is concerning and prompted us to review the speeds of the double decker buses on 6/20/24. According to our records, none of the double decker buses went below 9 mph while driving through the round-abouts. Drivers are required to keep a safe following distance behind other traffic (this is the case for all buses) as they take longer to stop. Traffic at that time may have been a contributing factor, as they are required to have a 4-second following distance between them and a vehicle in front of them. For what it's worth, none of our vehicles on 6/20 (or any day) will likely zip through a round-about doing 20 mph. Most will go between 10 and 15. We checked the speed at various sections of Loop Road for all our buses yesterday (measured between the two round-abouts) and speed ranged between 28 and 34 mph until Mendenhall Blvd. Then up to 35 – 40 mph after that intersection until the speed limit drops at the glacier (also normal for operating in these areas due to traffic). Coaches accelerate out of the round-about, but they don't have enough time to get up to the posted speed before they need to start slowing down in anticipation of the upcoming round-about (while maintaining following distance). As far as idling, we are in agreement that we don't want excessive idling at the glacier, (or any venue). We will take a look at our idling reports and deal with that accordingly to ensure drivers are following the idling rules set in place at the glacier. Temsco is operating 2 similar helicopters that produce less noise than the one operating in Auke Bay. It is more likely environmental conditions that will be a larger factor in how much sound is noticeable to an observer. A helicopter overhead will always have more noticeable sound than one that is even as little as ¼ mile away and downwind from the observer. The difference in overall sound between the majority of the helicopters used in Juneau and the one in Auke Bay as well as the two Temsco currently operates with this "quiet technology" is approximately a 5 decibel difference for reference. Technology helps with overall sound and it exists, but not to the extent implied by the caller. These helicopters are also not necessarily suited for the multi mission roles Alaskan helicopters operators require. Juneau operators are committed to mitigating noise to the best of our ability in as many ways as possible.
