

Visit San Antonio Summer Getaway Sweepstakes

Official Rules

Open to legal residents of the 50 United States and the District of Columbia, (“**U.S.**”) who are at least 18 years of age or older or have reached the age of majority in their state of residence at the time of entry. The Visit San Antonio Celebration Sweepstakes (the “**Sweepstakes**”) is governed by US law and is subject to all applicable federal, and state laws and regulations.
