

Board Chair Richard G. Stewart, Jr. called the meeting to order at 11:45 a.m. and inquired if there were any citizen comments; there were none.

### CONSENT AGENDA

- Approving ICVB Board Meeting Minutes for December 16, 2024
- Accepting the ICVB Financial Reports for October, November, and December 2024
- Reviewing the Hotel Occupancy Tax Collections
- Accepting the Irving Convention Center Financial Reports for November and December 2024

Stewart asked for a motion to approve the Consent Agenda as presented. On a motion from Board member Karen Cooperstein, and a second from Board member Julia Kang, the motion passed unanimously.

### PRESENTATION

Assistant Executive Director Finance and Administration Susan Rose gave an overview of the Tourism Economics Quarterly Update.

- Outlook for the Economy and Lodging in Irving, Texas:
  - Irving hotel room revenue is expected to grow 2.2% in fiscal year ending September 2025.
  - Room revenue is expected to grow 5.0% in fiscal year ending September 2026.
  - High income earners continue to spend, including travel/lodging.
  - U.S. luxury travel level has grown, while the economy has declined. Growing above the 2019 levels.
  - Low-income earners are dedicating more of their budget toward essentials due to inflation.
  - The economy is headed for a "soft-landing."
  - The results of the election and the current "limited Trump" scenario will positively affect the short-term, with negative effects anticipated in the long term.
  - The FIFA World Cup in 2026 is expected to positively affect hotel performance throughout the Dallas area, including Irving.
  - There are slight declines in hotel lodging demand despite gains in DFW Airport passenger volumes.

- The ICVB Conflict of Interest Form was distributed, and Board members should complete and return to Stewart or Executive Director Maura Gast.
- The next Board meeting is scheduled for Monday, February 24, and the location is to be determined.
- The new Board Member Orientation is being scheduled in the next few weeks.
- The Open Meetings Act required training by the City is online for newly and reappointed Board members.

### COMMITTEE REPORTS

Board and Business Development Committee Chair Michael Basoco reported:

- Basoco announced Committee Vice Chair Karen Cooperstein.
- The next Committee meeting is scheduled for March 14.

Community Engagement Committee

- Stewart noted Committee Chair David Cole is not in attendance today and announced Committee Vice Chair Cambria Jones.
- The next meeting is April 15.

Destination Development Committee

Committee Chair Colvin Gibson reported:

- Colvin announced Committee Vice Chair Julia Kang.
- The next meeting is scheduled for February 18 and is a special Committee meeting with a panel discussion. The panel includes representatives from three destinations and each panel member will be asked to discuss outcomes from challenges in their city. ICVB Board members, City staff and Council members are encouraged to attend.

### CITY REPORTS

Councilman Kyle Taylor reported:

- Thanked everyone for their support and kindness of Irving Cares. Irving Cares won the Agency of the Year award from North Texas Food Bank last year. He noted it is a true reflection on the community as a whole.
- PUD-6 Development Update: There is work to do on the language for this item. He encouraged Board members to call their elected officials if you believe in this project. The item will help Irving be the City we think it can be with this possible destination development.

Board member Yasir Arafat complimented Taylor on the efforts of Irving Cares food bank and their community work and presence. There is a large demand for food distribution in the community and the Islamic Center of Irving distributed more than a half million pounds of food last year and are now trying to expand the program.

City Manager Chris Hillman reported:

- City staff is focused on the upcoming legislative session with a goal to ensure that Irving protects its interests for Council to make decisions for the benefit of the community. There are 8,000 Bills introduced this session and 2,000 will have an impact on local government.
- Also focusing on DART and ensuring that as a City, Irving is getting all the value it can. Concentrating on "last mile solutions," which provides transportation options to connect riders from their homes or final destination to the nearest DART bus or rail station. Options in the past have not been successful but now engaging a micro-transit solution group that is being used in over 800 cities across the globe. They have proposed a solution for Irving that will be presented to the City's Transportation and Natural Resources Committee.
- Also want to ensure DART is an economic development partner, in particular a TIF District partner and contribute their dollars to help fund infrastructure transportation as needed (PUD-6 area as an example). DART is willing to work with the City on legislation changes and be managed more quickly and efficiently.
- On January 16, City Council approved the Construction Manager-At-Risk Contract for Senter Park Aquatics and Recreation Center. Construction of the 76-year-old pool will be completely torn out beginning in February. Also, the design is being finalized, and bids will be sent out for the new Mustang multi-generational aquatic facility. The facility is currently 17,000 square feet and the new state-of-the-art center will be 131,000 square feet.

In response to a question regarding DART's Last Mile program, Hillman replied he is not aware that street cars will be part of the conversation.

Chief Financial Officer Bret Starr gave an update on the Hotel Audit Collections:

An audit is done on each property every four years but will now move to every two years. The four-year program was started in 2019 running a four-year look back at hotel revenues. Notices have been sent to the delinquent hotels from the City. Hillman noted that approximately \$1.9 million is owed that the audit found over a four-year period.

Hillman asked Assistant City Manager Philip Sanders to give an update on the domestic violence shelter. The City is working with Family Place on a new domestic violence shelter on the size, scope of programs and services to be offered. A final report and recommendations will be completed by the end of February. Now that the Brighter Tomorrows program is gone, there is a large hole in the way domestic violence protection services are provided. Taylor noted his appreciation for the team working on the project and added it is one of the best vetted processes he has seen with an excellent group of people having hard conversations. It will be a state-of-the-art shelter that will fill a void for people around the region. Hillman noted the City will provide the land and Council has authorized \$2 million in Federal dollars and another \$3 million from the General Fund for construction. Mayor Stopfer and Hillman attended meetings last March in Washington D.C. and secured a commitment for another \$10.2 million. Estimates show assistance will be needed from the private business sector for this project.

Gibson applauded Hillman, Sanders and Taylor and asked what can be done to help between now and when the project is completed. It was noted emergency placement in shelters and short-term arrangements for a transition period can be made. Other shelters absorb the emergency overlap. Taylor added that some domestic violence cases may not be safe in Irving and moving to other areas is helpful.

### BUREAU MANAGEMENT AND STAFF REPORTS

Bureau Management:

- Gast gave clarity on the Hotel Occupancy Tax delinquencies and noted the City's audit identified \$1.9 million as not collected and not reported. Groups that were reported as exempt from Hotel Occupancy Tax should not have been and have been asked to pay those taxes by January 31. The assumption is there will be requests for extensions. The two delinquent hotels that owe \$2 million are separate from the \$1.9 million. There is starting to be movement from the law firm who is working with the City to be more aggressive in collections. Hope to have a trial date set or new information in the next few weeks. This is a total of \$4 million in Hotel Occupancy Tax owed.
- Headshots for Board and staff members who missed the previous session are available today.
- In reference to the Tourism Economics report, Gast added the Trump scenario impact on the marketplace for immigration, tariffs and fiscal policies is unknown and may influence workforce and trickle down to travel.
- FIFA World Cup events next summer have nine dates stretched across the course of the summer. This will affect hotel rates. Irving hotels will protect their rates and performance, which may limit the CVB in sales. There are strong hotel projections for next year, but soft from the CVB staff's ability to book groups with many available rooms being held back for World Cup.
- Gast thanked those that attended the Hotel Indigo ribbon cutting ceremony. It is a lovely property
  with meeting space and canal access and incorporates Irving in some of their features. Hillman
  added that the City recognized the opportunity to promote and reactivate the canal area. The City
  provided \$1 million in TIF funds with the goal to active and amenitize the quality of the canal.
  Parking was added for the canal area and Hillman thanked The Las Colinas Association for the
  study that was done three years ago that recognized parking and accessibility issues.
- The Board meeting menu for the meeting is to celebrate the Lunar New Year "Year of the Snake." Asked Assistant Manager Jeremy Pierce to pass along the great comments on the buffet and display to the F&B team.

Assistant Executive Director Sales and Services Lori Fojtasek reported:

- The Sales and Services full December 2024 report is included in the packet.
- The Sales team had an incredibly good December with 29,000 rooms booked, well over the goal.
- January the team hosted the Hilti Conference, which has been here for eight years and Family First Life. Next week the Southern Association of Agriculture Scientists, with 1,300 room nights and booked an overflow hotel.
- Fojtasek attended the Rare Steak Festival in Houston. Irving will host the event in May 2025 at Levy Event Plaza. Hotels that feature steak entrees have been invited to participate at no cost. The ticket sales will be limited to 1,500 at different price points. Working with Board member David Cole on restaurant participation and event details in hopes of having several DFW restaurants attend.

• Red Bull Flugtag event is not officially announced but will be held at Levy Event Plaza on September 13 and expecting 30,000-75,000 attendees. The event was in Irving in 2013 and was a good, fun, and successful event.

Assistant Executive Director Marketing and Communications Diana Pfaff reported:

- The Marketing and Communications December 2024 report is included in the packet.
- Headshot proofs will be sent out to Board members for review.
- Pfaff thanked the Las Colinas Association for hosting the recent meeting with Red Bull Flugtag. It is a huge event with months of planning between several City Departments.
- December is typically a slower month, but the team generated a 2,761% growth compared to previous month's modest 72 new subscribers with the Twelve Days of Holiday Giveaways Campaign. The campaign showed a 53.39% increase over last year's campaign. Numbers show the audience was engaged throughout the entire 12 days.

Assistant Executive Director Finance and Administration Susan Rose reported:

- The complete Hotel Performance and Short-Term Rental Report is included in the packet.
- STR Hotel Performance Data for November 2024:
  - Hotel Occupancy rate was 62.3%, a decrease of 1.3% from last year.
  - Average Daily Rate was \$126.74, an increase of 2.5% from last year.
  - RevPAR was \$78.94, an increase of 2.2% from last year.
  - Hotel Occupancy for Texas was 60.1%, and the U.S. was 59.4%.
  - Short term rental data shows there were 610 available listings in Irving. Occupancy was 54.2%, up 6.8% from last year and ADR was \$233.80, and increase of 14.7% over last year.
  - Comparable hotel subset, the Occupancy rate was 53.7%, an increase of 12.6% from last year and the Average Daily Rate was \$68.86, an increase of 14.9% from last year.
  - The Finance and Administration team:
    - Rose attended the Texas Association of CVB Conference (TACVB) in Waco, Texas last week with Fojtasek and Director of Sales Matt Tungett. She thanked Gast for the encouragement to attend and grow with these learning opportunities.
    - Gearing up for the 2025-26 Budget with the City's Kick-Off meeting today. Senior Accounting and Purchasing Assistant Monica Soto is representing the ICVB.

### CONVENTION CENTER MANAGEMENT

Assistant General Manager Jeremy Pierce reported:

- The full ICC Financial reports and General Manager's report for November and December 2024 are included in the packet.
- The first month of 2025 was highly successful.
- Launching a new CRM program in May for the Convention Center.
- The Finance Department is working on transitioning to new financial software.

### INDUSTRY PARTNERS

The Pavilion at the Toyota Music Factory/Live Nation Report Board member Tommy DeBeaudry reported:

• New budget is finalized with 36 Corporate events confirmed and 95-105 promoted events, and 10 special events. The show count is a work in progress.

• Hosting the Live Nation General Manager Road Show in early March with a visit from all Live Nation venues in North America for an annual conference with focus on new food and beverage.

### HOTEL INDUSTRY UPDATES

Board member Anthony Buttafuoco reported: Reporting for Omni Las Colinas for December:

- Occupancy comp set in December was 51.3%, a nice increase of 2.5%.
- Average Daily Rate of \$226.26, an increase of 15.7% for the month.
- RevPAR was \$113.96, up 18.5%.
- Year-over-year 7.5% growth in Occupancy, ADR \$231.06, and RevPAR \$155.87.
- Really healthy numbers for 2024 and hope to continue in 2025.

### Board member Kim Limon:

Reporting for Hampton Inn Irving/Las Colinas for December:

- Occupancy reporting 46.4%, down 19.8%.
- Average Daily Rate was up 8.4% and RevPAR of \$42.04, down 13.1% from comp set.
- Finished the year with Occupancy of 70.6%, up 2.8% from comp set, ADR \$117.94, down 4.9% and RevPAR of \$83.30, down 2.3%.
- Hotel is in need of renovation.

Board member Stephanie Fenley-Garcia reported on the Industry-at-Large:

- Consumer Electronics Show (CES), and Promotional Products Association International (PPAI) and World of Concrete show numbers are not available to date.
- The show moving into the ICC today has a great and fun presence in the lobby area. Happy to see good trade shows at the ICC.

### DCURD

Board member Dallas Burke reported:

- Hackberry Creek at Hwy 114 and Hwy 161 20,000 cubic yards were dredged from the site. This is approaching the largest dredging project since it was built.
- Removed 30 tons of trash and debris from Lake Carolyn during FY2023-24.
- Irving Flood 1 repairs to the Levee Slide completed.
- Irving Flood 3 wrapped up two projects, adding \$7 million of repairs and new equipment to the flood control system.
- Making improvements to fencing in Valley Ranch to assist with wild hogs challenge.
- Levee Certification Underway all three districts are FEMA re-certified.

RESTAURANT INDUSTRY UPDATES No report.

Greater Irving-Las Colinas Chamber of Commerce Chamber Chair Steve Love reported:

Irving Unemployment Rate has not been below 4% since March 2022, however, December's rate is 3.2%, lower than Texas at 3.7% and the National Unemployment Rate of 3.8%.

- The Fox 4 new state-of-the-art TV studio will be a two-story, 60,000 square foot modern studio with redesigned newsroom and podcast suites. The studio has been in Dallas for 75 years. Happy to welcome them to Irving.
- The Chamber participated in the grand opening of The Edged Dallas a 168,000 square foot sustainable data center. It is an AI ready facility that will lead the way in powerful and sustainable performance.
- The Dallas/Fort Worth Metro area was ranked the #1 destination for new residents last year, according to the annual U-Haul Growth Metros and Cities for 2024. Austin ranked #5 and Houston ranked #9.

### Irving Arts and Culture

Irving Arts Board Chair Chris Wallace reported:

- The performance of *Deathtrap* is closing in on the final weekend.
- *Memphis Soul* presented by Entertainment Series of Irving will be at the Arts Center on Friday, February 14.
- The Entertainment Series' youth outreach initiative Irving Youth Theatre will present *The Little Mermaid, Jr.* on Saturday, February 15.
- Sunday, February 16 the New Philharmonic Orchestra presents a *Whirl of Rhythm*.
- Saturday, February 22 the Irving Symphony Orchestra will present *The Best of Broadway*.
- February is Black History Month, and the Irving Black Arts Council will present its annual slate of programming: *Artistry Abounds: Selections from the Collection of Arthur Primas*. On Sunday, February 16 at 3:00 p.m., there will be performances featuring poetry readings and the unveiling of the USPS Black History Month stamp.
- New exhibitions:
  - Invisible Spaces: Watercolors & Drawings by Sudeep Kumar in the Focus Gallery on February 1. Also, there is a reception on February 8 from 5:00-7:00 p.m.
  - *Rachel Black: Journeywork* opens February 8 in Carpenter Lobby Gallery.
  - *Phases: Works by Toni Schuster & Richard Widener* also opens in the Courtyard Gallery on February 8 with a reception on February 15 from 5:00 7:00 p.m.
- Irving Archives & Museum: Smithsonian National Traveling Exhibition *"Japanese War Brides: Across a Wide Divide"* continues through April 6.
- Artists Alley at the Toyota Music Factory is a partnership between the Department of Arts and Culture and the TMF as part of their plaza renovation. Four pieces are featured by local artists as curated by Irving Arts Center and will be rotated periodically. It is exciting to see the City's Arts and Culture beyond the walls of our facilities in a highly visible space in one of Irving's premier entertainment-based developments.

Stewart noted he has served on two independent Boards with the City of Irving: the ICVB and the Arts Board, and glad to see Wallace back on both Boards.

- If anyone is interested in a keynote speaker or lunch and learn speaker, the University of Dallas staff can assist in helping find a faculty expert for your event.

## Housing Assistance Programs Available for Down Payment, Home Rehabilitation

The City of Irving's Housing and Redevelopment Division offers Down Payment Assistance and Home Rehabilitation Programs for Irving residents.

#### Homebuyer Down Payment Assistance (DPA)

This program provides up to \$50,000 to low-income families purchasing their first home. Funds come from the U.S. Department of Housing and Urban Development to provide affordable housing opportunities to residents. Newly built and renovated homes are made available to the DPA program participants through partnerships with nonprofit Community Development Housing Organizations.

DPA provides financial assistance to qualified applicants in the form of a zero percent interest, deferred forgivable loan. The funds can be applied to down payment and closing costs to purchase a home in Irving. Applicants must qualify under the Housing and Urban Development income guidelines, be approved for a home loan with a City of Irving approved lender and not have owned a home within the last three years.

Applicants can view all of the requirements for eligibility and information on how to apply at CityofIrving.org/DownPayment.





#### Home Rehabilitation Programs

The City of Irving administers programs, funded by the U.S. Department of Housing and Urban Development, that provide financial assistance to qualified Irving homeowners for home repairs through partially forgivable loans. Qualified repairs include accessibility issues, air conditioner repair or replacement, home exterior issues, and emergency and major repairs.

Irving residents must own the property needing repairs and is the primary residence for a minimum of three years. Visit CityofIrving.org/HousingApplications for more information and to apply. ■

## City of Irving's Live Fire Tactical Training **Center Construction Now Underway**



Construction has begun on the new City of Irving Police Department (IPD) Live Fire Tactical Training Center at the intersection of Belt Line Road and State Highway 161. The \$17.5 million facility was included in the 2021 municipal bond election

to help meet the needs of the police department today, while also anticipating the needs of the community 40 to 50 years in the future.

The new facility will include modern police training capabilities, including adding more space for long-range weapons training, as well as a dynamic, multi-use space for mobile tactical training.

With the new space, officers will have the flexibility to train in 20 lanes at 100 yards versus the old facility, which includes seven lanes at 25 yards. Additionally, the new space can accommodate vehicles inside the facility for scenario-based training.



The new facility serves as a prime example of Irving's dedication to providing the tools that public safety needs to be successful and keep the community safe.

The facility is slated for completion in early 2026, weather permitting.

## Hackberry and MacArthur Pump Stations Water Tank Rehabilitation



Work is underway for tank rehabilitation projects at the Hackberry and MacArthur Pump Stations. Ground storage tank rehabilitation for Hackberry Pump Station Tanks No. 4 and No. 5 and MacArthur Pump Station Tanks No. 2

and No. 3 keep the tanks on track with the 12- to 18-year maintenance schedule. This process extends the life of the system and minimizes the risk of unexpected repairs in the future.

Tank rehabilitation began with Hackberry Pump Station Tank No. 5 in December

2024 and will occur in stages through late summer 2026 to prevent disruptions to water service. Hackberry Pump Station rehabilitation includes cleaning, repairing and repainting Tank No. 5 and repairing the fill pipe support system at Tank No. 4.

## Work to Begin on New Indoor Pool at **Senter Park Recreation Center**



Construction on the new Senter Park Pool, located at 901 S. Senter Road, begins Feb. 10. The facility's existing

outdoor pool will be demolished and replaced with an indoor aquatics center that Irving residents of all ages can enjoy year-round. The new aquatics facility is expected to open Memorial Day weekend 2026.

The aquatics center will feature a leisure and lap pool with a maximum depth of 5 feet, spiral waterslide, zipline, toddler pool with interactive play features and an outdoor sun deck. Children's areas will be painted with rainforest imagery, while the lap pool will feature hexagon-shaped lane markers as a tribute to the hexagon island from the original Senter Park pool, built in 1954. In addition to aquatics amenities, the facility will offer a new reception area, lounge, party rooms and locker rooms.

Estimated to cost \$25 million, the aquatics center will connect with the existing Senter Park Recreation Center, making the entire facility approximately 67,000 square feet. The new Senter Park Aquatics and Recreation Center will share a front entrance on the south side of the building, facing Delaware Creek. The southern parking lot will be expanded to accommodate more than 150 parking spaces, and the tennis courts will be relocated to Senter East Park, 1000 Senter Road. Visitors to Senter Park Recreation Center can expect minor disruptions during construction, including increased



noise levels and construction traffic. Additionally, the northeast parking lot will be closed while construction is underway.

This project is part of the Let's Play Irving: Elevating Aquatics & Recreation initiative, which includes bold plans for Lee and Senter Park pools, as well as a multigenerational Mustang Park Recreation and Aquatic Center. Let's Play Irving projects are funded through the 2021 municipal bond election, the 2006 municipal bond election, pension bond capacity, the non-bond Capital Improvement Program (CIP) fund, the

American Rescue Plan Act, and unallocated non-bond CIP funds.

In January, there were 191 marketing prospects. Of those, 118 came from Cvent and 73 came from the website.




Aggregated Weekly Definite Volume of 200+ DMOs





#### Hotel Performance

Irving's hotel occupancy rate for December was 53.5%, a decrease of 0.7% from last year. The Average Daily Rate (ADR) was \$116.43 an increase of 2.3% from last year and Revenue Per Available Room (RevPAR) was \$62.34 an increase of 1.6% from last year.

The hotel occupancy for Texas was 52.4%, a decrease of 2.0% from the previous year and the hotel occupancy for the US was 53.2%, which was an increase of 1.1% from the previous year.

#### Short Term Rental

For the month of December, there were 602 available listings in Irving. The occupancy rate was 50.5%, down 5.6% from last year and the ADR was \$221.97, an increase of 25.6% over last year.

For the hotel comparable subset, the occupancy rate was 50.1%, a decrease of 1.3% from last year and the ADR was \$65.01, an increase of 3.7% from last year.

Occupancy vs. Same Month in Previous Year Last 12 Months



- Total event income missed budget by \$137,382. This was due to less attendance in one our largest revenue producing event for the month of January, Hilti, affecting our F&B catering income and internet sales, not to mention higher service expenses for the same event, DECA and Vogel.
- Other operating income includes January's Westin garage rent, Enterprise's rent, transient parking revenue, and various other commissions.
- Indirect expenses were under budget by \$29,162.
- Despite staying under budget in our indirect expenses, the ICC did not meet budget by \$177,388 because of the reasons mentioned above and additional expenses incurred for the transition of our new booking system.
