IRVING CONVENTION AND VISITORS BUREAU BOARD OF DIRECTORS MEETING IRVING CONVENTION CENTER MARCH 26, 2018

Chair Clem Lear called the meeting to order at 11:45 a.m.

CONSENT AGENDA

Lear asked for a motion to accept the Consent Agenda as presented. Board Member Rick Lindsey made a motion to accept; second by Board Member Joe Philipp. With no opposition and no further discussion, the Consent Agenda was unanimously accepted.

INDIVIDUAL CONSIDERATION

Executive Director Maura Gast presented an item to approve the recommended changes to the City of Irving Ordinance 16B-1 to forward to City Council. She reminded the Board the language change recommends formalizing the position of the Arts and Culture and DART representatives to the Board. Language was also added to the Restaurant position for term of service at the recommendation of the Greater Dallas Restaurant Association, in line with the Greater Irving-Las Colinas Hotel Association chair's seat; clarifying language regarding the term of the seat for the Former Board Member was also added. Board Member Debbi Haacke made a motion to approve the language changes as presented; second by Board Member Karen Cooperstein. With no opposition and no further discussion, the recommended changes to the City of Irving Ordinance 16B-1 were unanimously approved.

PRESENTATION

Gast gave an overview of the 2018-21 Strategic Planning Process, Destination NEXT background, and the D-NEXT Survey Kickoff. She asked that Board members respond to the survey online and explained the information collected will be categorized in many ways to ensure accurate results; i.e., age group, role in the community, client responses, etc. She further commented the data is only as good as the number and diversity of respondents. An email draft and postcard that Board members can use to distribute to encourage getting the word out to the community will be sent in the next week. The survey will launch April 4 and closes May 1, results will be presented to the Board on May 21 and incorporated into the Strategic Planning Retreat June 21-22.

REPORTS:

BOARD CHAIR - EXECUTIVE COMMITTEE

It was noted that Board Member Mark Cronenwett was not present for the meeting and recognition of his service to the Board and as Chair of the TIF Board will be postponed to a later date.

Lear recognized and congratulated High Spirited Citizen awardees Bob and Donna Bourgeois. She commented it is an honor to have Bourgeois on the Board and thanked him and Donna for their service to the community.

An ICTN video of the recent water infrastructure tour was viewed. A bus tour on March 9 toured the water infrastructure system and several Board members attended. Lear commented the tour was very informative and something that all Board members should attend if offered again. A suggestion was made to have a tour of the City's parks.

Lear reviewed the upcoming meetings and activities. Board Member Julia Kang reported the Big Beat Dallas ribbon cutting at the Toyota Music Factory will be on Thursday, March 29 at 4:00 p.m. The Grand Opening celebration is scheduled through April 2. A listing of activities for the weekend with details was distributed. Lear requested Board Members to "Like" and "Share" the Big Beat Dallas Facebook page. It was reported the Kid Kraddick radio show will be broadcasting live on Thursday, March 29 at 6:00 a.m. The Westin Convention Center Hotel topping off celebration will be held on April 12 at 11:00 a.m. at the construction site and will include lunch. The Toyota Music Factory ribbon cutting is scheduled for April 13 at 11:00 a.m. with a full weekend of activities planned. It was further reported the Las Colinas Association Bowl-a-thon supporting Irving Cares is on April 26 at the Irving Pinstack location. Board members were encouraged to sign up.

BOARD DEVELOPMENT COMMITTEE

Committee Chair Debbi Haacke reported the Committee met on March 16 and reviewed the strategic plan process. The Destination NEXT Survey will lay the foundation for a meaningful strategic planning retreat in June. She encouraged Board members to ask others to participate in order to achieve the diverse and beneficial information needed. Haacke reported new board orientation is scheduled for April 5, and she encouraged everyone to attend if they haven't attended in the last few years. She thanked the Board for approving the Ordinance language changes. The next meeting is scheduled for June 5 at the Irving Convention Center.

COMMUNITY RELATIONS COMMITTEE

Committee Chair Rick Lindsey reported March was a busy month for the Committee. He thanked everyone who attended the City Council meeting to honor Jim and Virginia Meler as High Spirited Citizens. He further reported he was honored to attend the City Council meeting and participate in Irving's recognition as a Purple Heart City. The award is very unique and is a special identifier for the City of Irving. The next Committee meeting will be held on April 3 at 10:00 a.m., and the Committee will brainstorm in identifying ways to contact active groups in Irving for the Destination NEXT survey. The Committee is aiming for 200-400 responses in order to have an adequate amount of data to make some good decisions and plan the future. He encouraged everyone to attend the April 3 Committee meeting.

DESTINATION DEVELOPMENT COMMITTEE

Committee Chair Greg Malcolm reported a Memorandum of Understanding with the Rugby Club organizers for the Spring Trail Park is being considered at the April 5 City Council meeting. The next Committee meeting will be held on May 15 at the Convention Center.

CITY REPORTS:

In response to a question from Deputy Mayor Pro Tem John Danish, discussion on hotel room size zoning cases was postponed until a later date if added as an agenda item. Chair Lear asked that the Destination Development committee take up the subject at its next meeting.

Councilman Oscar Ward shared his passion about the Toyota Music Factory and Big Beat Dallas and the opportunities they hold for the community. He further reported Irving was recognized as a Purple Heart City at the March 1 City Council meeting, remembering and honoring purple heart recipients.

Mayor Rick Stopfer reported he attended the Easter egg hunt last weekend, with over 5,000 children attending. Library Director Chris Dobson is retiring from the City and he congratulated her on years of service. He commented Live Nation has done an outstanding job in covering all the bases of diversity in booking events and he noted it is a great place for a networking opportunity. He assured the Board the City is working with the developer on some issues and noted it is a complex project, but City staff is dedicated to finding solutions to finish the project. Stopfer reported he is excited about the Westin Convention Center hotel and the project is moving at a good pace. An agreement with Verizon has been signed and the City will continue to work on the Texas Stadium site project, and hopefully the bridge will be started on the site in the next two months. Infrastructure construction will move forward in August/September, and the housing community continues to grow. The new owners of Williams Square will be reviewing the ground floor layout and some redesigning will be coming. He thanked everyone that participated in the water tour. Stopfer reported DART will have a hearing tomorrow night regarding the Cotton Belt, which creates north-south connections.

City Manager Chris Hillman thanked Ramiro Lopez and the City water staff for the water infrastructure tour. He commented it was very eye-opening and appreciated the time everyone took to see the facilities. He reported Verizon entered into an economic development agreement with the City, and Hillman thanked Senior City Attorney Karen Brophy and City Attorney Christine Weber in finalizing the documents and Irving-Las Colinas Chamber of Commerce President Beth Bowman for her coordination with Verizon on the project. Council of Governments (COG) and Texas Department of Transportation will transfer ownership of Irving Boulevard in the Heritage District. He thanked City staff for working hard on the project, and noted COG will fund 70% of \$12 million, and the project now has 100% funding up front by COG and will reimburse through TIF dollars. The "Road to the Future: \$100 Million in Five Years" project increased to a \$112 million investment, with \$12 million in the Heritage District. Hillman reported the Irving Police Department was recognized with the nation's highest award for good business practices. The Irving Police Athletic League is looking to expand their program to the armory building, and received a matching grant to retrofit the building and there will be further fundraising events to help that effort. The Police Awards Banquet will be held tomorrow night at the Irving Convention Center, and is a fundraising effort as well.

STAFF:

Gast reported Irving hotels will be receiving an email for the annual Needs Analysis Survey to kick off the budget process and assess priorities. She noted this is a separate survey from the Destination NEXT survey, but they will be receiving both soon.

Assistant Executive Director/Sales and Services Lori Fojtasek reported February was a short but busy month for the Sales and Services Department. The team has been traveling and now playing catch up, while doing budgets and local activities. In response to a question from Lear, Fojtasek report Drive Nation is started to schedule tournaments and room nights are beginning to be booked.

Assistant Executive Director Diana Pfaff reported website traffic was high again in February and the irvingtexas.com site had the second highest number of visits this fiscal year with 22,154 users. The Irving Convention Center website had 13,889 users, also above average. She reported information available through the ADARA Magellan travel intelligence platform indicates February performed exceptionally well and was the highest month since launched in May 2017. Estimates show that approximately 192 flights (which do not include Southwest Airlines), along with 785 room nights were booked, which accounts for \$123,968.25 in hotel revenue for the month.

Assistant Executive Director/Finance and Administration Mike Zumbaugh reported the January and February 2018 STR data are included in the packet. He reported Irving's Hotel Occupancy in February for the Competitive Set Comparison was higher than the U.S. and Texas at 74.4% and year-to-date at 70.2%. Comparing to last year, the U.S. maintained 1.2%, Texas is up 4%, most of last year Irving's Occupancy is down compared to 2016. However, February 2018 Irving's Occupancy is up 3.6%. Average Daily Rate for Irving is down 1.4% and year-to-date up 1.1% over last year. Zumbaugh reviewed a new report featuring data for AirBNB activity. He reported as of March 2018, there are 210 active listings in Irving; 83 rent the entire home, 110 private rooms and 17 shared rooms. He noted the data will fluctuate monthly. There are 107 active hosts, 73 rent a single property and 34 host multiple rental properties, 29 are considered super hosts (highly rated in the Air BNB system – achieved 4.8 rating or better, responsive, active hosting 10 stays per year, and reliable). He reviewed rental growth from 2011. He reported there will be graphs in the upcoming Board packets reviewing the data. In response to a question from Danish, Gast noted there is not specific information available for each separate property.

CONVENTION CENTER:

General Manager Tom Meehan reported the Convention Center is gearing up for a tremendous year. Staff is working on addressing lights on the outside upper canopy and will put in LED lights this year; lights over the escalator and the parking garage lights will be converted to LED. Lighting in the Grand Ballroom will be upgraded with more functionality. Safety and security continues to be a priority. Director of Sales Matt Tungett gave a report for February 2018. The building had 25 events, five more than last year for the month. To date there have been 111 events compared to 101 last year. The month of February set a record for 31 contracts to go "definite", compared to 14 February 2017. There are 134 Definite contracts for the year. The Convention Center surveys are scoring at 91.1% for the year, and 93.3% for the month. Leads are coming in for longer term bookings and the first contracts for the Westin have been received. DFW Fiber Fest will be held again on April 6-8. The event has been here for six years and has expanded its footprint and doubled space this year. The National College Fair will be here on April 9. The North Texas Teen Book Festival is quickly becoming one of the most well-attended shows and is scheduled for April 20-21. The Scrapbooking Expo was held last weekend. They relocated from Grapevine and 350 rooms were picked up at the Marriott Las Colinas (previously at the Gaylord Resort). They are working on details for booking next year and in the future.

INDUSTRY REPORTS:

THE PAVILION AT THE MUSIC FACTORY/LIVE NATION REPORT

Board Member Mike Rilley reported the Pavilion is celebrating 198 days of operating. The excitement with more and more opening in the Toyota Music Factory campus the guest experience has great energy and vibe, and he is proud to be a part of it. There are 70 confirmed shows this year, 23 are amphitheater seating. By the end of the year there should be more than 80 shows confirmed. The Pavilion has the advantage of being a year-round set up and not just seasonal. He reviewed some of the upcoming shows: The Australian Pink Floyd, Rise Against, Three Doors Down & Collective Soul. Managers and agents are started to book returning events, like Need to Breathe, the same manager for the G3 show books Sammy Hagar. Jeff Beck show last Friday night was sold out and it was the first show of the tour. They have a high-level management company that has booked some other bands at The Pavilion. This is about building relationships and the importance of making that happen. He announced two exciting shows in June: Post Malone on June 14 and Leon Bridges on June 19. Bridges is from Fort Worth and is a contemporary soul and gospel singer, and is treating this as one of the highest "coming home" parties this year. He is also starting his tour kickoff at The Pavilion. There are several more Latin shows announcing soon. On April 10, Gladys Knight and the O'Jays will be announced for a show in August. Rilley said everything is getting better and coming together, and it is a project to be proud of.

HOTELS AND RESTAURANTS

Board Member Greg Malcolm March is pacing the same as last year, Occupancy is 70.2%. Board Member Holly Turner reported the Omni had a soft January, but February and March have picked up and looking at a very strong first quarter.

TIF

Board member John Haigler reported TIF Board met on March 20. He reported the Water Street project is delayed slightly, but believes the agreement will be extended. The TIF Board is actively engaged with City Council on the recommendation of the TIF extension.

GREATER IRVING-LAS COLINAS CHAMBER OF COMMERCE

Chamber President Beth Bowman reported City Council approved the City's incentive for the Hidden Ridge development. This mixed-use development will transform Carpenter Ranch into a vibrant community. It will include walkable lifestyle core with retail, restaurants, and residential property, leveraging the new Carpenter Ranch DART station which will open as part of the Hidden Ridge project. It also includes two large office tracts, with another expected 1 million square feet of office space. The Irving Economic Development Partnership worked closely with Verizon, the project master developer and City staff to bring the deal to fruition. She reported Irving's unemployment rate for February is 3.6%, which is 0.1% higher than in January (up from 3.0% in December 2017). Texas' unemployment rate is 4.0, and national rate is 4.1%. Bowman reminded everyone the Irving Chamber Technology Leadership Council kicks off their 2018 Speaker Series tomorrow morning at the Jack E. Singley Academy. The Chamber's next quarterly program will be held on April 3 at the Dallas Marriott Las Colinas and will kick off a "Generations in the Workplace" series presented by Citi. On April 4th, the Chamber has partnered with the U.S. Chamber of Commerce and MetLife to launch the nationwide Small Business Master Class series at the Irving Convention Center from 8:00 a.m. – 2:00 p.m. The 2018 BEST in Irving Awards reception is scheduled for April 12 at Southern Junction.

CULTURAL AFFAIRS

Executive Director Todd Hawkins reported he attended NAFSA Advocacy Day in Washington, D.C. and met with state representatives to build arts and culture in Irving. Hawkins reported the Irving Arts camps are open for registration and run Monday through Fridays from 8:00 a.m. to 6:00 p.m. The week-long camps run from June 4 through the last week of July. The "Grant Wood and the American Heartland: Prints & Works on Paper" exhibit runs from April 7 through July 1. The exhibit features 19 lithographs Wood created during the Great Depression, and Irving is the only place in the country to see all of them.

With no further business or comments, the meeting was adjourned by Lear at 1:25 p.m.



Irving Rambler – Planes, Trains, and Automobiles (01/28/2017)

The City of Irving was born at the corner of what is now Main Street and the Trinity Rail Express. Two railroad surveyors were sent by the ROCK ISLAND RAILROAD to survey a new rail stop in the year 1903. The wife of one of the railroad surveyors was a member of the Washington Irving Society (whose namesake was America's first man of Letters), and she suggested naming this new rail stop "Irving".

Irving's reason for existence begins with transportation. Our great City's successes over the years have been built on transportation. Whether it be the Texas Stadium construction on the confluence of the three major freeways of Loop 12, Highway 183, and Highway 114 (which today we refer to as the Diamond Interchange of Walton Walker Freeway, Airport Freeway and John Carpenter Freeway) through which threads the NAFTA Highway of Interstate 35 connecting Mexico to Canada; or the

building of the Dallas Fort Worth International Airport (for which Irving serves as a one of the four host cities).

Irving's future success will continue to be based upon transportation with the modernization of Airport Freeway/Midtown Express and the completion of the Dallas Area Rapid Transit light rail line to terminal A at DFW Airport.

Irving's downtown centers have evolved from its original Main Street location to Plymouth Park, the Irving Mail, and the Las Colinas Urban Center. Further, the eighty-acre tear drop at the site of the former Texas Stadium offers the possibility for a four hundred acre spectacular, mega downtown.


Irving must maintain a clear focus on the full development of its transportation network rail component if it wishes to realize its full potential. I have attempted, via the following Exhibit, to portray how the rail corridors will complete Irving's future transportation needs connectivity.

Each rail corridor offers expanding opportunity for goods and services to trigger future development like the new VERIZON CAMPUS we anticipate at the Deferred Carpenter Ranch Station on the DART Orange Line.

Fort Worth's TEX Rail; the Cotton Belt Line; Burlington North Santa Fe Line; DART Orange Line; DART Green Line; and the Trinity Rail Express, when completed and fully operational, will provide Irving, Texas with one of the most comprehensive rail connectivity networks in any North Texas city.

In conclusion, it is not a coincidence that the new concrete panels along the updated Airport Freeway will portray Planes, Trains, and Automobiles. It is the essence of our heritage. Only by maintaining our commitment and focus to the rail component of Irving's transportation network can we achieve the full measure of the Birthright that our pioneering ancestors bestowed upon our great City.







Marketing and Advertising Analytics

RFPS

March was a strong month for RFPs with a total of **86** (above average) and **53,166 associated room nights** (well above average); this represents the highest number of requested room nights in any month to date. Of those room nights, **13,090 were associated with one RFP**.





Website Traffic

Website traffic remained high in March with **43,630** total sessions and **35,009** total users visiting both sites. The irvingtexas.com site had the highest number of website visits to date with **23,347** users (well above average). The Irving Convention Center website had **11,662** users (above average).

Visitors to the blog continues to grow dramatically, with **7,381 pageviews** in March, which is again the highest number of pageviews to date and nearly double the highest number of pageviews previously. The top blog posts were "Top Thing to Do in March in Irving" with **1,524 views** and "Easter Fun Around Irving" with **657 views**. Since the beginning of 2018, the blog has had a total of **21,518 pageviews**.




Advertising and Paid Search

Visit Irving's advertising is performing exceptionally well generating **7,083 Impressions** and **1,241 site visits**, which is the <u>highest response to date and more than double the highest response previously</u>. AJR Media was the top performer in March with 2304 impressions followed by MPI with 1,268 impressions, Connect with 575 impressions and 300 site visits, and Tegna Media with 468 impressions and 566 site visits.

The ICVB's ad campaign with *Fast Company* magazine continued with its fifth Irving-specific wrapped issue. A thousand (1,000) meeting planners throughout the country selected to get a year's worth of wrapped publications have received the May 2018 issue, "Center Stage," which focuses on Irving's new visitor district, highlighting all of its many facets: Toyota Music Factory, The Pavilion, Big Beat Dallas, Alamo Draft House, soon-to-open Westin Irving Convention Center at Las Colinas Hotel and more than 20 combined dining establishment.

Visit Irving's Google AdWords also performed well with **59,111 Impressions** and **6,850 site-visits** to the Irvingtexas.com and Irvingconventioncenter.com websites.



Hotel and Flight Bookings

Information available through the ADARA Magellan travel intelligence platform indicates that hotel bookings by people exposed to the bureau's advertising and digital marketing slowed down in March. Estimates show that approximately **190 flights** along with **238 room nights** were booked, which accounts for **\$28,255 in hotel revenue** for the month.







10 Fun, Under-the-Radar Things to Do in Texas

Check it out below.

1. Get your art fix at Cadillac Ranch.

The Texas Panhandle is home to some oddball art installations, and perhaps, none more so than Cadillac Ranch. Billionaire Stanley Marsh III bought a bit of property next to Route 66 in Amarillo, Texas, in 1977 in the hopes that an art installation could be built and would interest both locals and out-of-towners. An art group by the name of Ant Farm created what is now known as Cadillac Ranch. The installation features ten Cadillacs buried nose-down in the ground. Since 1977, it has become interactive, with visitors stopping by and spraying artwork or their names on the now-stripped Caddies. So, grab a can of spray paint (or one left behind) and get your art on in Texas.

2. Visit Texas Musicians Museum.

There are a plenty of reasons to visit the Texas Musicians Museum in Irving, Texas. The main draw, however, is the cool displays of famous Texas artists in a variety of genres. Get an upclose look at Willie Nelson's mug shot or watch the first music video on a vintage 50s-style tube TV. Take pics with the Stevie Ray Vaughan display, next to Selena's concert posters, or with ZZ Top's first concert performance flyer from his show in Wichita Falls, Texas. There are even modern displays of Destiny's Child and Jessica Simpson. It's a fun tour to take, and more than surprising when you see just how many famous artists came from Texas. Don't miss out on the live shows on weekends and be sure to snap some photos with the larger-than-life guitar and piano sidewalk art outside. And if you're willing to delve into the creepy aspect of the museum, ask about the ghosts and orbs that party around Janis Joplin's display at night.

New Entertainment District Expands Irving's Meetings Offerings

Irving, Texas is about to offer a lot more as a prime location for meetings and conventions. The Southwestern destination is currently developing the third phase of a 40-acre mixed-used entertainment district in the heart of Las Colinas Urban Center —

the city's international business district. The new visitor's district houses the Irving Convention Center; the recently opened Toyota Music Factory, a mega entertainment complex with dozens of trendy restaurants, bars, and live music; and the soon-to-open 350-room Westin Irving Convention Center Hotel at Las Colinas.

Rise and Shine at the Westin Irving Convention Center at Las Colinas Hotel

Opening late 2018, the \$113-million convention center hotel will offer 16,000 square feet of meeting space, including a 10,000-square-foot ballroom, cocktail lounge, and coffee bar. The 12-story hotel will be perfectly positioned between the convention center and entertainment complex.

The headquarter hotel represents the "crowning piece in Irving's vision (https://www.dallasnews.com/business/hotels/2017/03/27/irving-breaks-ground-convention-center-hotel-entertainment-district-preps-fall-opening) for a distinctive, pedestrian-friendly visitor's district," according to Maura Allen Gast, executive director of the Irving CVB. "The Irving Convention Center was the initial anchor; the Irving Music Factory with its Live Nation amphitheater and collection of restaurants is the second piece; and the hotel is the third."

Irving Convention Center at Las Colinas

The convention center itself includes a 50,000-square-foot, column-free exhibit hall and 20,000-square-foot ballroom. The 275,000-square-foot facility's vertical design creates interesting spaces for networking and allows attendees to move fluidly throughout the building. It's adjacent to the Dallas-Fort Worth International Airport and near Dallas' Love Field. The venue can be reached via nonstop flights from more than 170 destinations worldwide, including all major North American cities. And attendees are able to get to and from the convention center easily, with the recently opened Dallas Area Rapid Transit (https://www.irvingconventioncenter.com/attendees/transportation/) (DART) Orange Line, connecting the airport to downtown Dallas.

Eat, Drink, Rock 'N Roll at the Toyota Music Factory

The Toyota Music Factory opened in September 2017 and sits adjacent to the Irving Convention Center. This all-in-one dining and entertainment destination features 250,000 square feet of restaurant and retail space, in addition to a state-of-the-art 8,000-seat, indoor-outdoor Live Nation concert hall and amphitheater known as the Pavilion (http://www.thepaviliontmf.com/special-events/). The campus also includes a 50,000-square-foot outdoor plaza with daily live entertainment and a restaurant open 24 hours a day — perfect for special events and networking activities. Plus, there are more than 20 restaurants (https://www.guidelive.com/food-and-drink/2017/11/15 /restaurant-guide-dining-drinking-toyota-music-factory-irving). Attendees can enjoy a beer at the Thirsty Lion Gastropub and Grill, or grab a Teriyaki Twist bowl at the healthy fast-casual spot, Freshii.

"This easily accessed, pedestrian-friendly 40-acre district will provide a wide range of entertainment and dining options to fill free nights on the convention schedule," Gast said, "as well as to provide an excellent venue for opening or closing night events."

Take a Stroll on the Canal

On the edge of Lake Carolyn, Gables Water Street is a \$100-million residential lakefront development with 60,000 square feet of retail and restaurants. Water Street is sure to be a go-to place for attendees to spend leisure time, whether going for a stroll along the lake after a delicious meal, trying stand-up paddle boarding along the canal, cruising on a gondola, or enjoying a day at the spa.

Texas It up at the Texican Court

A kitschy boutique-style hotel, The Texican Court is also slated to open this year, giving visitors to Irving's Las Colinas Urban District another hotel choice within walking distance of the Irving Convention Center. The hotel's design will feature Spanish mission-style architecture with the subtle layer of Texas, making it uniquely Texican architecture. With a more intimate, laid-back feel, the property will offer 152 retroinspired guest rooms in addition to meeting space, including three distinct courtyards, each with its own style, and featuring a reception area, pool, and fire pits.

Give Your Attendees More Than a Meeting

Access is easy; folks are friendly; service is superior — and Texas hospitality simply can't be beat. Add a new center for food, music, and culture, and you've got a top-notch destination with plenty of options for lodging, nightlife, and innovative off-site events.

"The final piece is nearly here," said Chris Hillman, Irving City Manager. "With tremendous work and vision, this development will soon become a spectacular reality. These centrally located 40 acres will become a high-energy site, full of activity — people, music, entertainment, restaurants, retail, and an upscale hotel."

STR

Irving's hotel occupancy rate for March remained higher than US and Texas figures at 76.5%, and YTD remained higher as well at 72.4%. When comparing numbers to last year, the US Occupancy maintained a positive growth of 0.9%, while Texas figures were up 3.4% for the month. Irving's occupancy was up 1.8% compared to last year, leaving us with 0.7% YTD growth.

For average daily rate, Irving was \$107.92, up 0.5% in March compared to last year, leaving Irving's YTD average daily rate at \$109.88, up 0.9% over last year.

This month's snapshot feature report is of the Full Service Las Colinas properties.

In addition to the 10-year comparison of weekend vs. weekday numbers, I have included in the Board Report the 2017 Daily ADR, Occupancy and RevPAR graphs to help the board understand the pricing and occupancy swings the hoteliers face on a day to day basis.

<u>Air</u>BNB

As I reported last month, we now have access to AirBNB activity through a company called AirDNA.

As of today, there are 217 active rentals in Irving, up from 210 that I reported last month equating to a 3.3% increase in active rental listings. The number of active hosts also increased by 7, which indicates that all 7 new listings are single-listing hosts.

The current YTD average daily rate for these rentals is \$130.19, which is up 15.79% over last year, with an occupancy percentage of 63.9%, up 9.31% over last year. For the hotel comparable subset, the current YTD average daily rate is \$86.58, up 19.92% over last year, with occupancy at 62.2%, down 0.07% from last year. As a reminder, the hotel comparable subset are those properties that are one bedroom or studio apartments. As a comparison, and as noted above, the YTD hotel average daily rate is \$109.88.





Three Year Comparison - CITY OF IRVING - ALL PROPERTIES







Three Year Comparison - Full Service - Las Colinas




10 Year Occupancy Comparison - Weekday/Weekend

The count of Airbnb listings that were advertised for rent during the month or had a booked day in the month











It is easy to classify education with statistics; however, there is much more to the experience of young scholars. Relationships with caring teachers, diversity, strong family involvement and a range of extracurricular activities all positively mold the student from kindergarten to senior year. 
events. Las Colinas Elementary School even has classes specifically for special needs students and for students with autism.

Barbara Bush Middle School, the CFBISD's IB Junior High, boasts a gifted population of 10% and an award-winning orchestra program. What is notable about the school, though, is their Kickstart Karate program which is occasionally visited by a very famous Hollywood star. Icon and overall superhuman, Chuck Norris, is known to attend belt ceremonies and present awards to Bush karatekas.

Karate doubles as self-protection and as an athletic activity, but parents may still worry about safety in public schools. Principal Matt Warnock says that there is "a strong safety presence" at Bush Middle School; one security guard and one uniformed officer on campus at all times. With only 663 students, the school is smaller than most middle schools. Because of the small number of students and the many programs and extra-curricular activities offered, students are often involved in several programs which allow for a sense of community. This keeps students too busy to become interested in drugs or other sordid activities that might plague the typical junior high student at other schools. Bush students are active in groups, but they spearhead philanthropic efforts that benefit food banks, animal shelters, amputees, and individuals afflicted with tetra-amelia syndrome through the Learning for Limbs program.

The last stop before college for the IB student is Ranchview High School which provides several rigorous college prep classes. In fact, Ranchview High School has six college-level classes for full IB diploma candidates, and they currently have around 30 full diploma students. Leadership/dual credit programs for juniors and seniors help propel their higher education aspirations by offering 24 credit hours for free.

Free college classes cut down the student's expense and time on education, but Ranchview High School also has a thriving athletics program. "Football, basketball, cross country, swimming, swimming and dive, tennis, golf, track, and this year we will have both girls' and boys' soccer. Everything but wrestling." Sherri Skruch, Ranchview Principal smoothly recalls. This lengthy list doesn't include all the other clubs on campus. There is a hobby and a place for every student at Ranchview, and teachers strive to get the students

connected to a club, sport or art. Ranchview feels like a "private school in a public setting", Skruch says.

Everything unique and special about all CFBISD schools would be challenging to cover, but all in all, the mission, goal, and intent of the district is to continuously improve student learning, the learning environment, operational effectiveness, and community support. CFBISD schools are safe, dedicated to creating well-rounded, critically thinking, high achieving, college-bound students that will be able to perform and compete in global spheres.




add some chicken, falafel, tofu or steak?

LCA UPDATES: NEW ONLINE VOTING OPTION, NEW ACC MEMBERS

With so many new commercial and residential developments in the community, the Association has been keeping busy. Gables Water Street is shaping up and Toyota Music Factory has revitalized the Urban Center. The community can also look forward to two hotels and many more restaurants soon.

The Architectural Control Committee, along with Plan Review staff, are responsible for reviewing submissions. This time of year, Plan Review staff receive alot of submissions on landscaping, pools, decks and outdoor kitchens. Once the plans are received and approved, they are brought before the Architectural Control Committee (ACC) Residential Review Committee or the Commercial Review Committee for formal review. Both committees are made up of members from commercial and residential communities. This vear two new members have joined the Architecture Control committee. Dinah Kirkpatrick has joined the Residential Review Committee replacing Nora McCaa who served 2 years, 3 months and Residential Review Committee member Cheryl Feigenbaum has replaced Chris Allen who served 5 years, 2 ½ months.

Security Services still boasts a 5-second response rate from Patrol personnel and the Alarm Monitoring Service is rolling out a new wireless mesh radio alarm monitoring system this year. Our Security Services Department monitors members' existing security alarms for free. Members must have a City of Irving Alarm Permit and the alarm systems must be installed by a Texas State licensed alarm company. When Patrol is not responding to alarms or incidents, they are monitoring our community and responding to calls on open garage doors. In fact, in

2017, Las Colinas Association Patrol responded to an average of 366 open garage door calls per month! That's 366 times an opportunistic thief could have shopped for a new bicycle, weight set or maybe even try to get inside your living room to claim your big screen. Don't forget to close your garage door at night and when you leave your home. Open garage doors are an open invitation to property theft and it can be a costly mistake.

The Common Property Department is responsible for the beautiful uniform appearance of our green spaces, medians, shorelines, and parks throughout our community. They know their trees, ground covers, shrubs, and flowers! Now is the time to plant! This is a great time to plant ground covers, trees, and warm-season annual flowers. LCA's Common Property Department suggests that new trees should be fertilized to stimulate growth.

LCA's Community Relations Department, along with the Irving Economic Development Partnership and Dallas Business Journal, recently sponsored Corridors of Opportunity: Las Colinas, A Master-Planned Masterpiece. This event was held at Toyota Music Factory on March 1st and featured local top executive panelists: Krista Bourne of Verizon, John J. Hedrick of Pei Wei, Noah Lazes of ARK Group, Bill Lucia of HMS and Steve Van Amburgh of KDC Real Estate Development & Investments.

This year, the Administrative Department upgraded LCA's proxy vote system to allow both paper and online voting methods to better assist property owners in casting their annual meeting votes. Now property owners receive a code and website address via USPS mail.

Las Colinas, downtown Dallas poised to be North Texas' hottest office leasing areas

Dallas' Uptown district and Plano's Legacy area have been the hottest office leasing submarkets lately, and they will continue to sizzle as long as overall demand for space in North Texas stays strong.

But the up-and-comers for landing big deals in the months and years ahead seem to be Irving's Las Colinas submarket and the Dallas downtown core, Josh White, executive vice

president at commercial real estate giant CBRE's Dallas office, told the Dallas Business Journal in an interview about the state of office leasing.

"We're now seeing Las Colinas really catch this wave like they never have before," White said. "There is a significant amount of relocation/consolidation from household name type of users out in Las Colinas"

"We believe that, because of the availability of land, the relative price discount compared to Uptown and Plano Legacy, as well as proximity to the airport, that Las Colinas is going to be the next benefactor of this cycle in a significant fashion," he added.

The knock on Las Colinas over the years has been a lack of rooftops and a lack of amenities for corporate users, White said. That has changed significantly with the

Toyota Music Factory opening and other projects under construction or about to get underway.

Downtown Dallas will also win its share of leasing business in the months and years ahead, White predicted.

"There is some great energy happening in the core of downtown that is going to be the result of significant investments by folks like Craig Hall and Lucy Billingsley and (Tim) Headington," he said.

As rental rates continue to rise in Uptown, tenants will have to relocate into the core of downtown because of a lack of available space and rising lease rates, he said.

White's comments come on the heels of a CBRE report showing Dallas-Fort Worth office vacancy rates rose in the first quarter, and office leasing contracted for the first time in 31 straight quarters.

The market experienced a rare loss of over 470,000 square feet of absorption in the first quarter.

A combination of corporate consolidations into smaller spaces and newly-delivered construction kicked up vacancy rates by 0.9 percent to 20.5 percent. Asking rent rates were down 1 percent for a DFW-wide average of \$24.25 per square foot.

White thinks office leasing will level off, but he's not concerned about a long-term slowdown in DFW.

There are currently 25 companies combing North Texas for 100,000 square feet or more, White said. Those include what White characterized as "a healthy mix" of companies from outside DFW or the state, along with in-market relocations, consolidations and expansions.

Employment in North Texas remains strong, with the region handily outpacing the nation in new jobs, White added. The DFW economy ranks second in the nation for its 2.7 percent rate of job growth, and some 96,000 jobs have been added to the DFW employment base over the past year, the CBRE report says.

The biggest office leases of the year so far include Stewart Health Care's lease of 165,300 square feet of space in Richardson's Galatyn Commons, Guidestone Financial Resources' lease of 112,825 square feet in Pinnacle Tower in Dallas, and New York Life Insurance's lease of 107,267 square feet at Two Energy Square in Dallas.
