Chair Clem Lear called the meeting to order at 11:46 a.m.

CONSENT AGENDA

- 4. REVIEW OF 2017-18 SECOND QUARTER HOTEL OCCUPANCY TAX COLLECTION REPORTS

Lear referenced a memo in the meeting packet rom ICVB Director of Accounting Marianne Lauda noting further reporting clarification on the Hotel Occupancy Tax Collections report from the City of Irving. The City has contacted three hotels that claimed no taxable revenues for the quarters ending 12/31/17 and 3/31/18 to verify the information reported is correct. Lauda reported one hotel will be included in the current City audit and the others in future audit reports. Updates will be provided to the Board as they become available.

Lear asked for a motion to accept the Consent Agenda as presented. Board Member Karen Cooperstein made a motion to accept; second by Board Member Jo-Ann Bresowar. With no opposition and no further discussion, the Consent Agenda was unanimously accepted.

INDIVIDUAL CONSIDERATION

Gast gave an overview of the 2018-19 ICVB Operating Budget and Marketing Plan. She reported on the history of the Hotel Occupancy Tax, ICVB Net Operating Expenditure, ICVB Reserve Fund, and ICVB staffing. She referenced the \$400,000 transfer to the ICC Capital Reserve Fund and \$125,000 transfer to the ICVB Reserve Fund, noting that \$75,000 will be utilized that was previously set aside for the Westin Convention Center Headquarter Hotel opening events. She then reviewed the Hotel Needs Analysis Survey results and noted the wants/needs were more weekend business and sales and marketing support for SMERF, leisure, corporate, government and transient business. The concerns noted on the survey included new hotel inventory coming in the area and market saturation fears. She noted this was the first year that responses had not listed "a lack of things to do" as a concern. Gast then reviewed the key management goals, ICVB department and Convention Center overviews.

In response to a question from Bresowar, Gast explained in the city-to-city analysis for operating subsidy comparisons, data came from convention centers in the SMG portfolio that were of similar size, space, market and revenues to the Irving Convention Center. In conclusion, Gast reviewed the Irving economic impact figures from the Destination Analysts, Inc. 2017 Economic Impact Report.

Lear asked for a motion to approve the 2018-19 ICVB Operating Budget and Marketing Plan. Board Member Joe Philipp made a motion to approve; second by Bresowar. With no opposition and no further discussion, the motion was approved unanimously.

BOARD CHAIR REPORT

Lear gave a brief overview of the ICVB Strategic Planning Retreat that was held on June 21-22. She thanked ICVB staff for arrangements at the Alamo Drafthouse and Glory House Bistro, and thanked Board Members for their participation. She reported the Irving Arts and Culture Director Todd Hawkins gave a brief presentation on the museums and Arts Center plans. Joe Moses from the Irving Parks and Recreation Department gave an overview of the Parks Master Planning process. Lear reported Bill Geist from Zeitgeist Consulting was the moderator for the two-day retreat. Discussions were held on the relevance of the ICVB Vision and Mission Statement, the Board's role in the Texas Stadium site and Heritage District plans. Other topics were ICVB branding, iconic attractions, Tourism Improvement District (TID) and plans for advancing a TID through the State legislature in the next session. Citywide Wi-Fi, festivals, sports tournaments, young professionals, and city walkability were also discussed. The results and report from the Strategic Planning meeting will be reviewed with the Board in the next few months and topics for action will be divided among the appropriate Board Committees.

Lear reviewed the upcoming Board meetings and noted the Special Executive Committee meeting regarding the Compensation Study to be held on July 24 at the Irving Convention Center.

BOARD DEVELOPMENT COMMITTEE

Committee Chair Debbi Haacke gave an update of the June 5 Committee meeting. She noted ICVB Assistant Executive Director/Finance and Administration Mike Zumbaugh reviewed the ICVB structure and the research conducted in governance structure. A summary memo of those findings is included in the Board packet. Haacke reported the Executive Committee has supported the position to proceed with the current ICVB governance structure. The next Board Development Committee meeting will be held on September 14 with discussion on the legislation agenda and the Board appointment process.

In response to a request from Haacke, Zumbaugh gave an overview presentation of the new ICVB Board portal. The site is built with Responsive Technology and is tablet- and smartphone-friendly. Within the portal, Board Members can access meeting information, Board contact information, STR reports, marketing plans, forms and additional information and presentations. Any questions regarding the portal can be referred to Zumbaugh or ICVB Office Manager Carol Boyer. Bresowar thanked Zumbaugh and noted the portal will keep Board Members fresh and informed.

COMMUNITY RELATIONS COMMITTEE

Committee Chair Rick Lindsey reported the committee has been active and busy with the DestinationNEXT survey. He reminded the Board of the High Spirited Citizen recognition for Willie Cole at the Thursday, July 19 City Council meeting and encouraged everyone to attend. He noted two other HSC nominees will be awarded: Marilyn Willem on August 2 and Debra Cox on October 4, and there is an additional nomination in the pipeline for 2018. The next Committee meeting will be on July 17 at the Irving Convention Center.

DESTINATION DEVELOPMENT COMMITTEE

Lear commended Committee Chair Greg Malcolm for his representation at the recent City Planning and Zoning Committee on the Hotel Development Standards ordinance. Malcolm added it was good to hear most of City Council was not in favor of changing the ordinance. The direction given was given that any changes would be developed in consultation with the ICVB, Planning and Zoning, and hotel representatives. The next Destination Development Committee meeting will be held on August 7 at the Irving Convention Center.

CITY OF IRVING

Deputy Mayor Pro Tem John Danish gave a brief overview of the importance of parking and transportation in urbanism. Transportation connection between North and South Irving along the BNSF corridor could be considered and capitalize on the D-Link system. The D-Link is a free way for visitors and newcomers to explore downtown Dallas and is paid for by the City of Dallas, DART and other cities' economic development funds. D-Link is also a way to connect to other transit services. In connection of North and South Irving, hoteliers along the corridor could participate.

Councilman Oscar Ward commented everything is going strong at the Toyota Music Factory. He reported cities are creating ordinances to enforce Air BNB, Home Away, etc. participation in Hotel Occupancy Tax. Ward is talking to Texas House of Representatives Rodney Anderson to move forward and encourage the effort and would like support from the Board.

Mayor Rick Stopfer reported it has been a busy month: Luzon Park redevelopment completed, Juneteenth Celebration, two cemetery dedications, 50th anniversary of Ambucs, Canal Fest, July 4 parade, and Nancy Lieberman Charities opened two Dream Courts in Irving. He noted these are all things to be considered at budget time and is proud of the offerings through the Arts and Culture, Parks and Recreation program and what kids participate in at City of Irving facilities. The programs at the libraries and arts for youth in the summer months are a valuable asset for our citizens. The Parks Master Plan will expand and build stronger programs.

In an update on DART, Stopfer reported they hope to finish funding for the Cotton Belt project by the end of August. He reported he is confident the Cotton Belt project will be completed. In response to Danish's comments regarding the D-Link, Stopfer commented cost is always a challenge in participating in programs like D-Link, and the downtown alignment will take longer due to the level of federal funding.

City Manager Chris Hillman reported the City budget is in process. He encouraged everyone to talk about the Toyota Music Factory and communicate that attendance is going well and several restaurants are open. The glass and roof have been installed on the Westin Convention Center Headquarters Hotel, and the elevator should be completed by the end of July. The opening of the hotel is scheduled for year-end 2018. Hillman reported Phase I of the Midtown Express should be substantially completed by the Fall. Things are moving forward on the Signature Bridge and Diamond Interchange area around the Texas Stadium site and will help with economic development on those sites. Dallas-Fort Worth International Airport announced partial closure of one of its primary runways for pavement replacement and resurfacing. The first phase of work is expected to continue through early August. A full closure of the runway will begin in August and finish in December. The City is partnering with a non-profit organization, Operation Finally Home, and has identified a parcel of property to build a home for one of Irving's veterans and family. Hillman thanked Deputy City Manager Mike Morrison and Stopfer for their assistance in making this mortgage-free home a reality.

He commented the City is working on pool improvements at the Heritage Center Aquatic Center, and installing turf at the newly renovated Twin Wells Golf Course that is re-opening later this year. Upcoming events include July 4 parade and fireworks, Clear the Shelter event, and no-fee pet adoptions. The Parks and Rec Master Plan is being put together and Hillman encouraged everyone to participate in the online survey at https://letsplayirving.com.

STAFF

Gast thanked everyone for their participation in the Strategic Planning meetings and she is looking forward to what the plan will deliver over the next several years. A handout was distributed of the July Calendar of Events at the Toyota Music Factory.

Assistant Executive Director/Sales and Services Lori Fojtasek reported the Sales team is busy closing out the quarter and everything is looking well.

Assistant Executive Director/Marketing and Communications Diana Pfaff reported advertising numbers continue to break records with 8,220 advertising impressions generated in May and 3,100 site visits, which is the highest response to date for the third month in a row. The Visit Irving Facebook page received the largest increase in May with 839 new Likes and passed the 50,000 Like milestone. Pfaff noted the Marketing Plan is in Draft form, and a new copy with updated numbers will be available for the City's budget retreat. She thanked Director of Marketing Monty White for his hard work on the plan. Board Member and staff headshots will be scheduled by the end of the summer.

Assistant Executive Director/Finance and Administration Mike Zumbaugh reviewed the Air BNB report, stating the current YTD average daily rate through May is \$138.01, up 13.64% over last year. Occupancy percentage is 62.0%, which is up 3.55% over last year. He noted the hotel comparable subset are those properties that are one bedroom or studio apartments. As a comparison, the YTD hotel average daily rate is \$110.22. The current average daily rate through May is \$86.48, up 15.85% over last year. Occupancy is down at 60.1%, down 3.76% from last year. There are 229 active rentals in Irving, and is a 44.9% increase in listings over last year's figure of 158. He reported there is still a lot of activity, but numbers are diluted with more inventory available from last year.

CONVENTION CENTER

ICC Director of Accounting Verenis Pedraza reported the Convention Center had another solid month and continues a record-breaking year. To date, the facility is \$552,000 ahead of budget for the year. Food and Beverage continues to grow at an amazing rate and is \$300,000 ahead of last year's pace. Sales have also been incredible as rental income is \$106,000 ahead of budget and \$208,000 ahead of last year.

ICC Sales Manager Case Villaseñor reported there were 22 events hosted in May, and 186 year-to-date, which is 17 events more than 2017 at this time. There were 23 signed contracts, 206 contracts year-to-date and 27 ahead of last year. The sales team booked 2,040 guestrooms in conjunction with the ICC programs, which is almost 2,700 room nights ahead of the 2017 pace. June had three large programs: the Telangana American Telugu Association had the full building for three days and 4,000 people in attendance, Steubenville had 4,700 in attendance over three days with over 3,000 room nights. The first of the Jehovah's Witnesses programs will finish the month with over 4,000 people. They have three more events in 2018 and sales has sent five agreements to them for 2019. There are two public shows in July: North Texas Comic Book Show on July 20-22 and Let's Play Gaming Expo on July 25-30.

INDUSTRY PARTNERS HOTEL AND RESTAURANT INDUSTRY UPDATES

Board Member Greg Malcolm reported Occupancy for Irving was 74.5% in May, up 2.5% from last year. Average Daily Rate is \$109.09, compared to \$110.74 last year in May. RevPAR is \$81.26 compared to \$80.50 last year. Malcolm thanked everyone for coming to the Hilton Garden Inn DFW South for the Board meeting and encouraged everyone to tour and see the renovations of the lobby and meeting room space.

Board Member David Cole reported Southern Junction Restaurant has closed in Irving and is being sold with a different idea/theme. Danal's Restaurant was lost in a fire and now closed. The National Restaurant Association announces the ServSafe Workplace program, which will offer training programs focused on creating and sustaining a positive work environment for the restaurant/hospitality industries. The Texas Restaurant Association Marketplace will be held July 15-16 in San Antonio. Cole reported new restaurant openings in Irving include: Whiskey Cake, Torchy's Tacos, Liberty Burger, India 101, Hooters and Texas Roadhouse. With over 18,700 square feet of space, India 101 is the largest Indian restaurant in North America.

THE LAS COLINAS ASSOCIATION

TLCA President Hammond Perot reported there are an average of 366 calls to LCA in a month to report garage door issues. There was a recent alarm system radio network crash, and the new wireless alarm system did survive through the down time. He reported there are several development projects in and around the Urban Center area, and a new first design review project is in progress. The focus is on walkability, mobility, way finding, and pedestrian safety. He noted TLCA association member dues are due July 1 and will be considered delinquent as of July 31. The Association members budget is in process.

DCURD

Board Member Jacky Knox reported the Water Street APT station construction should be completed by the end of June. There will be system testing to complete before the station is open to the public. Williams Square Plaza update consideration is on the City Council agenda this week regarding a recommendation of a design firm, which was the original designer of the Plaza. He reported possible TIF #1 extension parameters and projects are in the process of consideration by the TIF Board and eventually will be presented to City Council. Irving Flood Control District (IFCD) 3 projects include approximately 1,500 linear foot of Cowboy Canal wall construction which will take three years to complete. A slope stabilization project along Valley Ranch Parkway will include plantings and wall construction. IFCD 1 renovation is complete along the East Cell levee. The certification by USACE and FEMA will likely require approximately one year to process.

IRVING-LAS COLINAS CHAMBER OF COMMERCE

Chamber President Beth Bowman referenced an article in *D* Magazine Special Edition highlighting Irving as one of <u>"The Next Wave – these historic downtowns re poised for greatness"</u>. She thanked the City's Corporate Communications team, ICVB and Pfaff, LCA and Perot and the Chamber team who worked to put the piece together. Bowman reported there have been 14 economic development wins since October 1, with more than 2,000 jobs, and \$20 million in capital investment. The Chamber is currently working on 30 projects, 25 of those are domestic. The unemployment rate in Irving is at its lowest level this year at 3.3%. Texas has an unemployment rate of 4.1% and the national rate is 3.8%, which is the lowest since April 2000.

IRVING ARTS AND CULTURE

Arts and Culture Executive Director Todd Hawkins thanked Gast and Lear for the invitation to speak at the recent CVB Strategic Planning meeting and added he appreciates the support for the Arts programs. Hawkins reported "<u>The Mother Road Revisited: Route 66 Then and Now</u>" is exhibited in Carpenter Lobby through September 2. The exhibition aims to explore the idea of travel and American culture through interactive photography. Also, "<u>KidsArts/Kids' Works: Route 66 Summer Camper Creations</u>" features artwork from Irving Arts Center's summer art campers. The exhibition is in the Focus Gallery through August 25. Irving Quilt Guild will be featured in the Focus Gallery June 16 – July 8 with quilts created by members of the Irving Quilt Guild. "<u>The Chinese Garden Party</u>" is an annual exhibition of Chinese brush paintings, and Ikebana, the Japanese art of floral arrangement and is in Carpenter Lobby through July 8.

With no further questions or discussion, Lear adjourned the meeting at 1:43 p.m.





1.5-mile expansion of A-train Rail Trail expected to open late summer

The Texas Department of Transportation and the Denton County Transportation Authority aim to expand a current pedestrian trail alongside Interstate 35E by opening another 1 1/2 miles of trail later this summer, said Ryan Lafontaine, a spokesman at TxDOT. The A-train Rail Trail is designed to provide pedestrians and cyclists a safe opportunity to travel the whole trail or ride the commuter rail line during a break, according to the DCTA website. When completed, the trail will connect downtown Denton to Hebron Station in Lewisville and all A-train stations in between.

The project page said the trail is one of DCTA's efforts to "provide safe, customerfocused, and efficient mobility solutions to Denton County."

The trail currently runs from the Brock Downtown Denter Transit Center to Swisher Road in Lake Dallas and from Old Town Station in downtown Lewisville to Hebron Station.

Lafontaine said the 1 1/2-mile stretch beyond Swisher Road should open later this summer.

"TxDOT has been talking to the contractor, and they currently are trying to get vegetation established, so depending when they get the grass to grow, TxDOT should be able to open it the next few weeks or so," said Michelle Raglon, a spokeswoman at TxDOT.

DCTA lists three phases in the A-train Rail Trail project on its website.

The first phase was the construction of the 8.6-mile Denton Branch Rail Trail — downtown Denton to Lake Dallas — which was completed in 2011. The second phase added 4 miles from Old Town Lewisville to Hebron Station in 2016.

Another portion of the second phase includes construction of the trail between Highland Village/Lewisville Lake Station and Old Town. Currently, this portion is under final review with TxDOT, but construction is expected to begin this fall.

The third phase is the current construction of the trail between Swisher Road and Highland Village/Lewisville Lake Station. Lafontaine said that phase has been divided into two sections — a north section and a south section.

"We're going to open the north section hopefully in August, and that south section should be done some time in February," Lafontaine said.

Lafontaine said they are waiting for beams to be delivered and installed for the pedestrian bridge in Lewisville before they open the south section.

DCTA and Lake Dallas also are coordinating a ribbon-cutting ceremony for when the 1 1/2-mile stretch opens, Lafontaine said.

A facility status map on the <u>DCTA website</u> shows a regional trail, which includes the A-train Rail Trail, from Denton to Dallas has been funded through the North Central Texas Council of Governments. NCTCOG works together with federal and state agencies, the North Texas Tollway Authority and private-sector partners to ensure plans for transportation projects are fully funded before construction begins, according to its website.

Future construction is planned from Hebron Station in Lewisville to the northern part of Campion Trail in Irving, and from Las Colinas Urban Center Station to the southern part of Campion Trail, also in Irving.

DCTA did not respond to calls for a comment on the regional trail as of late Tuesday afternoon.

The A-train Rail Trail project is expected to be completed in early 2019.

Survey Results Reflect Continued Increases in Resident Satisfaction

Results from the 2018 Resident Survey are in. Approval of city services ticked up again in 2018, continuing the upward trend that began in 2006.

Conducted every two years, the Resident Survey is a tool used by the city to collect feedback from residents about what is working well, what needs improvement, and what services should be the highest priorities. It provides residents with an opportunity to rate the quality of life and the quality of city services in Irving.

Seven out of 10 residents rate the overall quality of life in Irving as "good" or "excellent." This rating can be attributed to Irving as a place to live and work, and the overall quality of services provided. When compared with the county, state and federal governments, residents' highest satisfaction is with Irving. Three out of four residents rate the professionalism of city staff and the knowledge of city staff as "good" or "excellent." services and continue to feel safe. Fire and ambulance services are again the city's highest rated services at 86 percent and 85 percent respectively. Police services also rated high at 80 percent — four-point increase from the last survey conducted in 2016. Residents rate the overall quality of city services high, with three out of four rating it "good" or "excellent."

"The recent survey shows the city is succeeding at providing outstanding service delivery and promoting a high quality of life for our residents," said City Manager Chris Hillman. "Residents feel positive about the direction the city is taking and recognize the work being done across the city that makes Irving an exceptional place to live and work. Residents also identified opportunities for continued improvement during the next two years."

ENGAGEMENT OPPORTUNITY IRVING 360°

Those who live or work in Irving and want to get an up-close look at government operations are encouraged to apply for the Irving 360° civic academy. The 11-week series of interactive sessions offers selected participants a behindthe-scenes, 360-degree view of exactly how a city operates.

The Irving 360° curriculum includes an overview of all essential functions of city government, facility tours, and is it a great networking opportunity for those who want to become more involved with the Irving community. Upon completion of the program, participants will take part in a special recognition ceremony with city leadership. Designed to increase community engagement, the City of Irving is offering this program at no cost to participants. Interested in learning more or want to apply? Communication also is rated extremely high, with "City Spectrum" being rated at 91 percent by residents. The city's website continues to be rated high, as 89 percent of residents find it to be "useful" or "very useful."

Community services is an important area for residents. The overall quality of libraries is the highest rated community service with 82 percent of residents rating it "good" or "excellent." The overall quality of parks, parks facilities, walking trails and the Irving Arts Center is highly rated by seven out of 10 residents.

Irving residents are very satisfied with public safety

These focus areas include street maintenance and conditions, corridor enhancements, street lighting, development and redevelopment, and police and fire services.

The 2018 Resident Survey was sent to more than 10,000 households, and the city received more than 1,600 responses. Residents will have the opportunity to provide additional feedback and take part in a dialogue with city staff in upcoming focus group discussions. 

City Spectrum

This printed newsletter is mailed once a month to all Irving residential postal customers and serves as a main source for city information. Issues feature everything from updates on economic development, news from city departments, schedules for recreational classes and programs, and details on special events. Electronic versions of latest and past issues are available for download at CityofIrving.org/178/City-Publications.

City Spectrum Digital

"City Spectrum Digital" is a resident's weekly source for the latest Irving news and announcements. The electronic newsletter hits email inboxes every Wednesday afternoon to update subscribers on construction projects, special event details, trash collection, and holiday closure reminders and much more.

With a digital version delivered via email, subscribers can get news on their smartphones or tablets to read anywhere at any time. Stories featured in "City Spectrum Digital" are shorter and easier to digest versions of stories in "City Spectrum." Sign up is quick and easy, CityofIrving. org/Newsletters.

City Spectrum Briefs

For every Irving resident who receives a city-issued water bill, "City Spectrum Briefs" is included with their

statement. "City Spectrum Briefs" is a single-page publication that provides information from various departments in a "brief," easy-to-read format. For residents who do not receive water bills, the most recent issues can be downloaded at CityofIrving.org/178/ City-Publications.

Social Media

The City of Irving also sends regular updates and advisories via social media. Most platforms offer residents the chance to engage with the city through "comments," "replies" or direct and private messages.

Shared content also includes links to stories featured on the city website. The Facebook Event Calendar gives followers the option to receive reminders for upcoming special events.
- The city's Twitter feed features faster, shorter, realtime updates. Twitter is most beneficial for road detours or closures happening "right now." Twitter also helps communicate vital information in emergency situations.
- **Instagram** serves as a look at everything visually happening in Irving. Whether it is animals up for adoption, an upcoming special event or a park, Instagram is where followers will see it all.
- The **Nextdoor** platform allows users to learn about major road projects and closures, special event details, animal adoption drives and more. Nextdoor also offers residents the option to tailor messages they receive to their specific area of the city.

RESIDENTS REMINDED TO FIGHT THE BITE WITH FOUR Ds

The City of Irving takes mosquito control very seriously. The city has 24 trap and spray locations. In the case any traps test positive, Irving's vector control technicians will spray at night.

How can residents help? Self-protection is the best course of action, so be sure to follow the four Ds:

- Dusk and Dawn When mosquitoes are most active.
- **Drain** Eliminate standing water, such as in flower pots, rain gutters, etc.
- **DEET** Make sure insect repellent contains this ingredient. DEET has been tested and approved by the U.S. Environmental Protection Agency.
- **Dress** Wear long sleeves, pants, shoes and socks when outside.

City Hoping for 'Hole in One' with Newly Renovated Golf Course

The City of Irving is getting close to completing the former Twin Wells golf course. When the course reopens later this year, residents can expect a new name, a newly organized course and a number of other upgrades.

Crews closed the course in October 2016 to begin renovations. Before the aesthetic work could begin, crews first focused on the course's 30-year-old infrastructure. A new irrigation system was needed. The new system features high-density polyurethane pipe, which adapts better to shifting soil. A new water transfer pump station also was installed. The station draws water from the Trinity River to keep the course irrigated. The city is saving money on irrigation by using some of its permitted reuse (recycled) water in the river. The water is discharged from the Trinity River Authority's treatment plant just upstream of the pump station.

Because the course is situated on a floodplain, crews improved drainage contours to allow the course to shed flood water more efficiently. Once this work was completed, crews began reorganizing the layout and flow of the course. The grounds where the former back nine were located will now sit as the front nine. The newly designed back nine were restructured to give players a more challenging game.

"Irving is essentially getting a brand-new golf course, and staff is doing a great job with this project," said City Manager Chris Hillman. "Residents are going to see and experience an incredible facility."

The renovation project includes rebuilt fairways, tee boxes and greens to include the planting of new grass in these areas. New sand bunkers will be installed, and the driving range and practice putting green will be realigned. Because of the reorganization of the course, new grass was planted on the tee boxes, fairways and greens.

"For three decades, Twin Wells Golf Course catered to golfers in Irving and across North Texas," said Irving Mayor Rick Stopfer. "I'm very excited we're bringing it back and even more excited to play."

Earlier this year, residents were invited to a meeting to discuss renaming the course. The new name and logo will debut before the grand opening, which city leaders say should happen in early November. ■

Online Input

Residents provided input on the budget during public hearings held earlier this year. 



During heat waves, be mindful of the following heat safety tips:

- Stay in air-conditioned buildings as much as possible.
- Avoid direct sunlight.
- Those without an air conditioning system should seek refuge in an air-conditioned shelter during extreme heat.
- Do not rely on a fan as a primary cooling device during an extreme heat event.
- Drink more water than usual, and do not wait for signs of thirst to drink.
- Avoid alcohol or liquids containing large amounts of sugar.
- Wear loose, lightweight, light-colored clothing.
- Seek medical care immediately when experiencing symptoms of heat-related illness such as muscle cramps, headaches, nausea or vomiting.
- When planning activities, choose cooler hours to be outdoors.

Another good rule of thumb is to listen to weather forecasts before prolonged work or exercise away from air conditioning, as forecasters often will provide heat warnings. Visit CityofIrving.org/Emergency-Management for more information.

In November 2017, the North Lake Natatorium reopened after an extensive remodeling project.

The 50-meter indoor swimming facility is open for yearround classes and swimming activities for the Irving community. The natatorium is a joint effort with the City of Irving, the Irving Independent School District (IISD), and the Dallas County Community College District. The facility is operated and managed by the City of Irving for joint use by the city and IISD. The natatorium is located on the North Lake College campus, 5001 N. MacArthur Blvd.

It is the only Olympic-size pool in Irving and is used by IISD, O2 USA Swim Club, Irving Sharks and other local schools for swim team practices and competitions. In addition, the Irving location provides a home to the Pirouettes of Texas synchronized swim team, as well as swim lessons, water aerobics classes and other recreational events.

Senter Park Recreation Center to Receive Interior, Exterior Improvements Through CDBG Funds

Senter Park Recreation Center, the city's oldest, largest and most frequented recreation center, has been operational since 1954.



Throughout its lifespan, the facility, which is located at 901 S. Senter Road, has seen renovations in the 1970s and 1990s. Currently, Senter Park Recreation Center is in the process of a three-phase project to improve the interior and exterior

grounds of the facility. The renovations are aimed at improving the patron and employee user experience.

The project is made possible through the Community Development Block Grant (CDBG) funding, which is provided to the City of Irving from the U.S. Department of Housing and Urban Development. CDBG funds are used in Irving to help improve the quality of life for lower income residents. In 2017, phase one improvements began on the Senter Park playground, tennis court, fencing and drainage.

In March, phase two of the construction began. This phase includes replacement of the Senter Park gymnasium and pool roofs, and an upgrade of the outside marquee sign to a modern, digital monument sign. Also, the parking lot light poles will receive LED lighting updates and a fresh coat of black paint. In the fall, phase three of the construction is slated to begin. This significant renovation of the interior will include relocating the fitness and weight room from the first floor to the second floor. The new workout area will provide added space and natural light for patrons. The area also will include new locker room and restroom facilities. On the first floor, crews will renovate the current exercise room into an activity room space and update the first level restrooms to meet Americans with Disabilities Act requirements.

The main reception area will be updated to provide an open and inviting space. Offices for staff will be reconfigured in place of the current Sports Hall of Fame, and the athletic memorabilia will be relocated and showcased within the upcoming Irving Museum and Archives facility. In addition, a television lounge will be constructed on the first floor.

The Senter Park Recreation Center project is scheduled for completion in the summer of 2019. For more information on Senter Park, visit CityofIrving.org/Senter.



Marketing and Advertising Analytics

RFPS

The number of RFPS received in June, along with associated room nights, increased over the previous month with **81 RFPs** (average) and **43,046 associated room nights** (above average).






Website Traffic

Website traffic also remained high in June with **48,676** total sessions and **36,854** total users visiting both sites. The number of sessions on the Visit Irving site was the highest to date with **33,999** total session (well above average). The Irving Convention Center had **14,677** sessions (slightly above average).

The number of visitors to the blog increased over last month with **7,544 pageviews**, which is the second highest month to date bringing the total number of pageviews in 2018 to **42,654**. The top blog posts in June were, "Five Brunch Spots in Irving You Need to Try this Sunday" with **1,204** pageviews and "Top Five Places to Stuff Your Face with Donuts in Irving" with **1,044** pageviews.







Advertising and Paid Search

Advertising engagement continues to perform exceptionally well with **7,164 advertising impressions** and **2,651 site visits**. June was the third highest response rate to date. iExplore was again the top performer with 2,296 impressions and 1,294 site visits followed by the retargeting campaign through Multiview with 1,458 impressions and 304 site visits and MPI with 1,131 impressions and 331 site visits.

The Google AdWords paid search campaigns increased last month with **57,450 impressions**, **7,540 site visits** and **7 new RFPs**, which was the second best performing month to date.

The ICVB's ad campaign with *Fast Company* magazine concluded with its sixth Irving-specific wrapped issue. A thousand (1,000) meeting planners throughout the country selected to get a year's worth of wrapped publications have received their final complimentary issue, "A Package Deal," which summarizes messaging from the five previous cover wraps. Past front cover artwork can be found on the inside back cover. Early survey results have shown this campaign to be extremely successful, and we will be looking to do a similar campaign in the next budget year.







Hotel and Flight Bookings

Information available through the ADARA Magellan travel intelligence platform indicates that hotel bookings by people exposed to the bureau's digital advertising or visited the websites was low in June. Early estimates show that, approximately **191 flights** along with **162 room nights** have been booked, which accounts for about **\$19,957 in hotel revenue** during the month. The platform has an attribution window and final numbers for June won't be available until the attribution period has finished.


Year to date total for FY17-18 shows that approximately **\$404,045 in hotel revenue**, which is estimated to be about 70% of the total, has been booked by individuals who have visited either the Visit Irving or Irving Convention Center websites.





Social Media

June 2018 Exploring the 'Social' Side of SMERF Meetings by Ann Shepphird



The SMERF (social, military, education, religious, fraternal) banner covers an array of groups that on the surface would seem to have little in common, pertaining to everything from weddings to military reunions and fraternal conventions.

What these groups share, however, is that their gatherings bring together people who are actively choosing to get together.

"SMERF groups are convivial and actually want to spend time together versus having to spend time together networking in order to meet an obligation," said Andrea Kinney, who plans gatherings for a number of SMERF groups as a St. Augustine, Fla.-based director of global accounts for HelmsBriscoe (http://www.helmsbriscoe.com/).

Of course, that convivality comes at a price—for the venue, rooms and food and travel—and the attendees usually pay for it out of their own pockets instead of it being something they can expense.

"The common bond is that they're self-funded social groups," said Ray Casey, president of Military Reunion Planners (https://www.militaryreunionplanners.com/), based in Grapevine, Texas.

Because of this, these groups tend to look for the best deals they can find from destinations and hotels, without skimping on quality. When the economy is struggling and corporate groups aren't booking as much business, the SMERF groups—who tend to meet no matter how the economy is doing—are very popular, but in today's market, with its high hotel occupancy, it can be a bit more challenging.

The good news is that when SMERF groups and the host destinations and hotels are able to work together they can find a balance that rewards their loyalty and the long-term relationships that have been forged.

Accommodating Loyal Customers

"It's a cyclical business that goes with the economy," Casey said. "When it's in the tank, hotels are begging for our business and will give us anything we want. Now that business hotels are full, some are not interested."

This is where the relational aspect of the meetings industry comes into play and, according to Casey, military groups remember who was loyal to them.

"I remember the ones that turned me away," Casey said. "The hotels I work with the most have been loyal and will still work to give us a deal when times are good. It might be harder to get some concessions—breakfast, parking, etc.—but they try to keep the rate down for our guys."

For family reunions and weddings, Kinney has found that booking all-inclusive resorts like those in the Dominican Republic and Jamaica can help keep expenses down.

"All-inclusive resorts are perfect for weddings and reunions because no one has to worry about who will pick up the tab when enjoying meals together," sad Kinney said. "Since the activities are also included everyone can enjoy time together doing something fun and not worry about breaking the bank." -69-

Flexibility in Dates and Rates

Casey and Kinney both advise their groups to be flexible on dates.

"Dates are a big driver," Casey said. "We try to educate them to be flexible if they want the same experience."

"I like to say that there are no bad rates, just bad dates," said Jason Dunn, vice-president of multicultural sales and community development for the **Cincinnati USA CVB** (https://www.cincyusa.com/), who touts the importance of the SMERF market for his city. "The SMERF market is under appreciated but it's a consistent revenue generator."

Katherine DiPietro, national sales manager for the Irving (Texas) CVB (https://www.irvingtexas.com/), agrees and points out that the market is valuable to her city because it can fill rooms on days of the week when the corporate market isn't meeting and that with all the new development surrounding the Irving Convention Center (including two new convention center hotels and entertainment options), they can now book larger groups.

"Many of the SMERF groups choose to meet on the weekends and in Irving we are able to offer incredibly good rates over the weekend patterns," DiPietro said. "Hotels and convention centers are always looking for ways to fill gaps in their calendar and are willing to negotiate better deals during those times."

Kinney tells her clients to have a preferred set of dates and at least two alternatives.

"Be willing to arrive on a Sunday and depart on a Wednesday, or arrive on a Wednesday and depart on a Friday," Kinney said. "This is especially important in vacation destinations where the leisure market drives up the prices on the weekends."

She also advises clients to not just pick dates and send them to attendees before asking for quotes.

"I see that often and it's a big mistake because you are locked into those dates," Kinney said. "And definitely don't broadcast a destination without making sure it's a viable one. I have had SMERF clients choose the Caribbean in the middle of hurricane season and, because they didn't realize it and had already sent a 'save the date,' they tried to make it work. Even if there isn't a hurricane, it will still rain—a lot."

Meeting Planning Know-How

Having the expertise of a professional meeting planner is not always something SMERF groups realize they need. Many begin hosting gatherings in an informal way and then realize they're in over their head.

Casey said that many of the military reunion groups he works with start by finding each other on social media and then at some point begin thinking about getting together in person and don't realize all of the logistics (and negotiating skills) involved in planning a meeting.

"There's no national organization, it's just a bunch of people trying to put it together and 99 percent of them try doing it themselves at first," said Casey, who added the biggest challenge is letting people know the type of services that are available to them. "Later they end up begging us to help because to do it well and do it right requires a lot of work."

This meetings expertise is particularly important when it comes to signing hotel contracts, especially in today's market.

"It is a hotel sellers' market and hotels will take advantage of SMERF planners who don't know how to book a group or are unfamiliar with contract language," Kinney said. "Sneaky contract clauses can cost an organization a lot of money. Third-party planners know what to look for and how to negotiate those 'bad clauses' away."

Kinney said she can also offer strategies on how to save on food and beverage.

"A good strategy is to toss the catering menus and ask to meet with the chef," Kinney said. "Let him or her know your budget and ask how they can design a great menu within those constraints. A good chef will love it because they get the opportunity to be creative instead of working off a menu that they may not have had any input in."

Kinney mentioned that a third-party planner's buying power can also help with getting better rates and extra concessions and that while some of the largest hotel brands are reducing commissions for planners they still want their business. "They know that if they treat our clients right, we will come back with more clients," Kinney said.

A Growing Market

The buying power of the SMERF market in general is growing.

While the acronym has historically referred to social, military, education, religious and fraternal groups, many destinations now include other groups in the mix. For example, in Irving, Texas, it also includes the tour and travel market, while in Cincinnati it also includes multicultural gatherings.

Dunn said the key to bringing SMERF groups to Cincinnati has been establishing a relationship with them, as they did with the A.E.A.O.N.M.S. (Ancient Egyptian Arabic Order Nobles Mystic Shrine) (http://www.aeaonms.org/), a fraternal group that has met in Cincinnati twice in the last 10 years.

"Most of our conventions are in repeat cities that are familiar with us and we have good relationships," said Frederick Bell, imperial convention director, who reported that registration for the organization's Imperial Council Session typically runs to around 5,000 members and 13,000 total room nights.

"These markets are very relational so we need to have sales managers who understand the market," Dunn said. "It's not a typical sales process; you have to actively engage and be involved in the community and then build that bridge to your city."

An Ongoing Relationship

Perhaps because of the relationships that are established, Dunn said he has seen an increase in organizations seeking ways to give back to the cities where they're meeting and have forged those close connections. "Groups are increasingly looking for ways to partner with cities on the kinds of things that can re-energize and inspire their membership," Dunn said.

Jonathan Williams, president and CEO of the Battleship Iowa Museum (https://pacificbattleship.com/), a popular site for military groups meeting in and around the city of San Pedro, Calif., said that he has found that groups are starting to add more community service projects to the events held on the ship.

"We tend to see the younger generations of veterans interested in giving back and being involved in the community," Williams said. "In the coming years, I envision veterans reunions turning into more of a community engagement activity where they may adopt a project aboard the ship and couple it with memorial services and banquets."

STAYCATION AT THE FOUR SEASONS





After checking in, we headed to LAW, one of the on-site restaurants, for sips and bites. The deviled eggs were SO good.



<u>STR</u>

Irving's hotel occupancy rate for June remained higher than US and Texas figures at 79.41%, and YTD remained higher as well at 74.4%. When comparing current month's occupancy numbers to last year, the US Occupancy maintained a positive growth of 1.7%, while Texas as well as Irving figures were up 4.6% for the month. Texas attained a 4.0% YTD occupancy growth, while Irving had a 1.8% YTD growth.

For average daily rate, Irving was \$108.29, up 3.7% in June compared to last year, leaving Irving's YTD average daily rate at \$109.85, up 1.4% over last year. Both current and YTD ADR figures were ahead of Texas' numbers.

AirBNB

There are 209 active rentals in Irving, up from 229 that I reported last month, but is a 29.0% increase in listings over last year's figure of 162. Irving currently has 148 active hosts, up from 135 last month.

The current YTD average daily rate through June is \$140.76, which is up 11.16% over last year, with a YTD occupancy percentage of 64.0%, up 9.27% over last year. For the hotel comparable subset, the current YTD average daily rate through June is \$87.20, up 14.3% over last year, with YTD occupancy at 61.8%, up 1.47% from last year.

As AirBNB inventory can fluctuate, thereby causing the current month variances to be erratic, I typically focus on YTD numbers. However, I would like to point out that June 2018 realized a 38.96% increase in occupancy over June of 2017, attaining an occupancy percentage of 72.7% and the Hotel Subset had a 32.67% increase in occupancy over June of 2017, attaining an occupancy percentage of 69.4%.

- We hosted ten events for the entire month of June, which is, by far, the fewest of any month this year. The reduction in overall number of groups is due to hosting several multiple-day, building-wide programs.
- These large programs led to a reduction in direct event income; however, we far exceeded our ancillary income target due to the large contracted food and beverage minimums.
- Our biggest contributors for the month were Telangana American Telegu, Hilti, and Steubenville, generating over \$300,000 in catering revenue alone.
- We continue to clean up our capital fund account, which added unexpected costs to a few line items under indirect expenses.
- Overall, the ICC beat budget for the month of June by a little over \$63,000.


